SUBJECT: Recap for December 5, 2025 Committee Meeting

SIGNIFICANT REPORT ITEMS

- The December 2025 meeting of Governor's Advisory Committee (GAC) on DUII was held at the Department of Public Safety Standards and Training (DPSST) in Salem, OR. The meeting featured an update by the Oregon Health Authority (OHA) regarding their proposed project to adapt the American Society of Addiction Medicine (ASAM) Fourth Edition. It also includes updating Oregon Administrative Rules to review payment methods and developing program policy guidance. The OHA had intended to start a transition project in December 2025. However, that process, which includes input from statewide substance use disorder (SUD) stakeholders has been delayed into early 2026. Various partners and stakeholders of the GAC on DUII and committee liaisons were encouraged to participate in the OHA public hearings and open forums. OHA intends to conduct a follow-up presentation to the committee later in 2026.

COMMITTEE ACTION ITEMS / RECOMMENDATIONS

- Committee members were provided with information regarding an Oregon Government Ethics Law update (effective January 1, 2026, and part of HB 2930) that outlines Oregon committee members' responsibilities and guidelines related to accepting or receiving personal gains which could result from their committee representation.
- Ryan Stone from ODOT TSO provided an update on NHTSA's impaired driving assessment, which will take place in the first week of February 2026. Various committee members and committee liaisons will be contacted regarding their participation in the assessment.

UPCOMING COMMITTEE MEETING / NOTEWORTHY AGENDA ITEM(S)

- The next committee meeting will be January 6, 2026, at DPSST in Salem and will feature an update on Washington's proposed .05 BAC DUI legislation. The meeting will
