Provides that person commits offense of driving while under influence of intoxicants or offense of operating boat while under influence of intoxicants if person drives vehicle or boat and has 0.05 percent or more by weight of alcohol in person's blood.

HB 3136 INTRO

Provides that person who operates motor vehicle upon premises open to public or highways of this state is deemed to have given consent to submit to drug recognition evaluation under certain circumstances.

Provides that agency or organization that refers person to treatment program for alcoholism, drug dependency or dependency on inhalants may select treatment program in another state where person resides if that treatment program is equivalent to treatment program in this state approved by Director of Oregon Health Authority.

Makes changes to statutes related to operating vehicle or boat while under influence of intoxicants that reference controlled substances to clarify applicability to psilocybin.

Requires state agency that enters into certain interagency agreements with public body, another state agency or unit of local government to evaluate performance of other party to interagency agreement at least once each year on basis of specified criteria and to determine every six years after date of execution of interagency agreement whether to continue or renew interagency agreement or terminate interagency agreement and enter into new interagency agreement with different public body, state agency or unit of local government.

Requires health care provider and health insurer to collect from patient, client or member data on race, ethnicity, preferred spoken and written languages, disability status, sexual orientation and gender identity.

Directs Department of State Police to maintain staffing level of at least 15 patrol troopers per 100,000 residents of this state, beginning January 1, 2030.
