Findings:

The average number of citations issued per day was higher prior to the reduced staffing of the Traffic Division. In 2019 the average number of issued citations per day was 47.0 which decreased to 37.5 in 2020. Citations dropped to 17.0 per day in 2021, the year Traffic Division staff were reassigned to Patrol and decreased further to around 14 per day until the reinstatement. After the reinstatement of the Traffic Division the number increases to an average of 27.5 issued citations per day. In the second part of 2023 the average daily number of trauma collisions and injury collision GO reports has increased compared to the first part of the year.

Data Notes:

The statistics represent the number of citations issued, DUIs that resulted in an arrest, and trauma injury crashes. Trauma injury crashes are represented using three sources. 1) Trauma collision calls were identified by examining call logs. It includes any call where an officer notified dispatch that an involved party would likely be admitted to the hospital as a trauma patient. Collision stats only include cases cleared with ACCNON, ACCINJ, ACCUNK, and ACCHRP. Statistics do not include ACCHR – Cold Hit and Run calls. 2) GO reports where the offense was an injury crash. 3) MCT serious injury/fatal collisions include all callouts except for suicide events and medical events.
