Guide to Obtaining Quotes for Electric Vehicle Charging Stations



Under the Oregon Department of Transportation's Community Charging Rebates (CCR) program, applicants are required to obtain one quote for electric vehicle (EV) charging station equipment and installation. An applicant can obtain a quote for their EV charging project from their electric utility, local electricians, charing equipment manufacturers or network providers.

Electric Utilities

Contact your electric utility early in the planning process, regardless of if you obtain a quote from the utility. Notifying the utility as soon as planning begins saves time down the line in a project. Many Oregon utilities offer technical assistance or can connect you with installers.

Finding Local Electricians

Service Level Agreement and Maintenance Contracts

Applicants must provide a Maintenance Contract or Service Level Agreement (SLA) along with proof of upfront payment for five (5) years of maintenance services. If the Electric Vehicle Service Provider (EVSP) you are working with does not offer an SLA, you can contact the electrician involved in your project to see if they provide one.
