### ODOT LETTER OF SUBSTANTIATION

*The Pacific Northwest Regional Council of Carpenters and its affiliated Locals were merged into the Southwest Mountain States Regional Council of Carpenters on June 5<sup>th</sup>, 2023. With the change of the Regional Council demographic now encompassing 12 states the Regional Council changed its governing bylaws to be equitable to all 12 states at the September 12, 2023 Regional Council Delegates meeting. It was a unanimous vote by all Delegates to change the name to the Western States Regional Council of Carpenters. This is the governing body for all 12 states, the Western States Regional Council of Carpenters is based at 533 S. Fremont Ave. Los Angeles, CA 90071.*

*Previous to the Regional Council merger, the Carpenters Locals of Oregon and Southwest Washington were also merged on March 1<sup>st</sup>, 2023. Locals 146 and 1503 were merged into Local 503 which cover the members residing in Wahkiakum, Cowlitz, Clark, and Skamania Counties in Washington State and Clackamas, Multnomah, Washington, Columbia, and Clatsop counties in Oregon state. Local 271 was merged into Local 541 which covers all members residing in all remaining counties in Oregon State.*

*With the Mergers mentioned, the Oregon and Southwest Washington AGC Collective Bargaining agreement for the scopes covered in our bargaining area have not changed and are still current until the expiration date stated in the Document.*

*The Locals covered under that agreement are Local 196 (Piledrivers), Local 503 (General carpenters, Scaffold, Bridge and Highway) and Local 541 (General carpenters, Scaffold, Bridge and Highway) Local 96 (Millwrights) are covered under the Millwright Regional Master Agreement (MEA).*
