

INTRODUCTION

This publication is intended to help you understand and interpret entries on the driving records available from Oregon Driver and Motor Vehicle Services (DMV) ordered on/after July 6, 2020.

RECORD TYPES

There are five types of driving records available: Certified court prints; non-employment driving records; non-employment, open-ended driving records; and employment driving records.

- The **certified court print driving record** includes most traffic violations and accident entries for at least the previous five years. Serious criminal traffic offenses, such as driving under the influence of intoxicants, may remain on the record permanently.
- The **3-year non-employment driving record** has entries for at least the previous three years. This record lists all non-employment-related accidents, convictions, suspensions, cancellations, revocations, and diversion agreements.
- The **non-employment**, **open-ended driving record** contains the same information as a nonemployment driving record but is not limited to three years and is available only for the purpose of providing insurance discount(s) to an individual.
- The **3-year employment driving record** is a three-year record that is limited to convictions and accidents the driver had while on the job.
- The **certified court print with CDL medical certification driving record** is a certified court print that includes commercial driver license medical certification information.


For each record type, there are two versions of the record available: (1) a version containing the driver's personal information and (2) a version that has the driver's personal information removed (sanitized). Personal information is removed from a record if a requestor does not qualify to receive it under Oregon's Record Privacy Law (ORS 802.175-802.191) or does not have a written, notarized permission slip from the individual whose information is requested.

Personal information is: driver license, driver permit or identification number; name; address; and telephone number.

Under Oregon's Record Privacy Law, only certain qualified entities are allowed to receive personal information. These include such entities as attorneys, legitimate businesses, insurance companies, police agencies, and other government agencies. The above example is a Driver License Information record, which has minimal information. Each driving record is certified at the bottom of the last page.

Each driving record is printed with Oregon state letterhead. It starts at the top left addressed to the individual or agency that ordered the record followed by the letter identification number and the date it was issued on the top right. The header of each page of the record has the date it was issued, the page number, and the letter ID number.

The record type is listed above the General Information section in the middle. This will tell you what type of driving record that is being viewed.

CERTIFIED COURT PRINT DRIVING RECORD

This is a certified court print that includes convictions for traffic crimes, commercial driver license entries, diversion agreements, and alcohol rehabilitation entries; convictions for minor offenses and accidents will show for at least five years. Withdrawals such as suspensions, cancellations, and revocations also are included, along with miscellaneous administrative entries and multiple status entries. It may also contain some out-of-state commercial driver entries.

3-YEAR NON-EMPLOYMENT DRIVING RECORD

This is a certified three-year record that includes Oregon accidents, diversion agreements, and convictions other than those in the employment driving record. The record may contain some commercial driver license entries, some out-of-state commercial entries, miscellaneous administrative entries, and multiple status entries.

NON-EMPLOYMENT OPEN-ENDED DRIVING RECORD

This record is available only to an insurer, insurance support organization, and the person to whom the record pertains for the purpose of providing a discount to the individual. It contains the same information as a non-employment driving record but is not limited to three years.

3-YEAR EMPLOYMENT DRIVING RECORD

This is a certified three-year record of Oregon employment related convictions, accidents, and commercial driver license entries. It may contain some out-of-state commercial driver entries, multiple status entries, and miscellaneous administrative entries.

CERTIFIED COURT PRINT with CDL MEDICAL CERTIFICATION DRIVING RECORD

This is a certified court print that includes commercial driver license medical certification information.

DRIVER LICENSE INFORMATION

This record provides basic information about an individual including the status of their driving privilege and any current license or identification information.

License Information and Status: Displays the class of License the individual most recently has had, if any, along with any applicable Endorsements and/or Restrictions.

Status: Displays the status of any license or identification card the individual has along with the date and time of that status. Statuses may include valid, eligible, expired, suspended

ID with Primary = An ID card that was issued prior to (7/6/20) when a suspended driving privilege was unexpired.

60-Day Temp	60-Day Temporary Permit - Allows operation of a vehicle consistent with an existing Oregon driving privilege in the event that a renewal or replacement of the existing issuance is not possible.
90-Day Temp	90-Day Temporary Permit - Allows operation of a vehicle consistent with an existing Oregon driving privilege in the event that a renewal or replacement of the existing issuance is not possible.
CDL Class A	Commercial Class A Driver License - With applicable endorsements and no restrictions, allows operation of any vehicle or combination of vehicles.
CDL Class B	Commercial Class B Driver License - With applicable endorsements, allows operation of any single vehicle regardless of weight, and to tow a vehicle that has a gross vehicle weight rating (GVWR) or gross vehicle weight (GVW), whichever is greater, that does not exceed 10,000 pounds.
CDL Class C	Commercial Class C Driver License - With applicable endorsements, allows operation of any vehicle that is designed to transport 16 or more persons, including the driver, if the gross vehicle weight rating (GVWR) or gross vehicle weight rating (GVW), whichever is greater, is less than 26,001 pounds and the person has a passenger endorsement. Additionally allows, with applicable endorsements, operation of any vehicle used in the transportation of hazardous materials, in quantities that require placarding by law (subpart F of 49 CFR part 172), if the GVWR or GVW, whichever is greater, is less than 26,001 pounds and the person has a hazardous materials endorsement.
CLP Class A	Commercial Class A Learner Permit - With applicable endorsements and no restrictions, allows operation of any vehicle eligible to be operated under a Commercial Class A license for learning purposes while appropriately supervised.

CLP Class B	Commercial Class B Learner Permit - With applicable endorsements and no restrictions, allows operation of any vehicle eligible to be operated under a Commercial Class B license for learning purposes while appropriately supervised.
CLP Class C	Commercial Class C Learner Permit - With applicable endorsements and no restrictions, allows operation of any vehicle eligible to be operated under a Commercial Class C license for learning purposes while appropriately supervised.
DSS Permit	DSS Authorization Permit - A person whose driving privileges are suspended under division 74 rules, who is otherwise eligible for driving privileges, may obtain a 60-day restricted license for the express purpose of taking driving lessons. Driving lessons must be provided by a commercial driving instructor, a rehabilitation specialist or other licensed driver approved by DMV as an instructor. Moped-Restricted	Moped-Restricted Class C License - No longer issued, but are eligible for renewal and replacement. Does not grant driving privileges. Allows operation exclusively of mopeds as defined in ORS 801.345.

NCL Class C	Non-Commercial Class C Driver License - With applicable endorsements, allows operation of any vehicle for which a commercial license is not required.
NCL Class C Permit	Non-Commercial Class C Instruction Permit - With applicable endorsements, allows instructional operation of any vehicle for which a commercial license is not required.
NCL Class C Prov	Provisional Non-Commercial Class C Driver License - Provisional license provided to 16-17 year old applicants. With applicable endorsements, allows operation of any vehicle for which a commercial license is not required.
NCL Class C Prov Permit	Provisional Non-Commercial Class C Instruction Permit - Instruction permit provided to 15-17 year old applicants. With applicable endorsements, allows instructional operation of any vehicle for which a commercial license is not required.
Parking ID	Parking Identification Card - Does not grant driving privileges. Issued to individuals who require a parking permit but do not have a valid driving privilege or ID card, and going to a DMV field office would be impractical or harmful to the individual.
Quit Driving ID	Quit Driving Identification Card - Does not grant driving privileges. Issued when a customer is surrendering their driving privilege for specific reasons.
Special Student	Special Student Driver Permit - Driving permit provided to applicants at least 14 years of age.

Accidents are posted to a driver's record after a reportable accident. Oregon law requires an accident be reported to DMV when one or more of the following occurs:

- An injury or death to any person;
- Damage to the vehicle you were driving is over \$2,500;
- Property damage (not including a vehicle involved in the accident) is over \$2,500; or
- Damage to any vehicle is over \$2,500 and any vehicle is towed from the scene due to damages from the accident.

An accident is displayed as shown above and the following entries show the formats that Oregon uses to post accidents to driving records.

Date: Date the accident occurred

Type: Type of accident or collision that occurred

CMV: Driving a Commercial Motor Vehicle (Y/N)

Accident Id: DMV reference number. This number is assigned by the Accident Reporting Unit to identify the location of the accident report.

Police Report: A police report was provided

Fatality: Fatal accident (Y/N)

Employ: Accident was employment related (Y/N)

Violation: The conviction ACD code or Oregon literal and Oregon Revised Statute. A list of standard violation codes are listed on page 66

Degree: The degree of the conviction; Violation, Misdemeanor, Felony

Verdict Date: The date the court convicted the driver of the violation

Jurisdiction: The state or jurisdiction code from which the sanction was submitted from.

Location: The court or agency that ordered the suspension. Full list of Location/Courts are found on page 79

Case#: The case or docket number from the court

Speed: If conviction listed is for speeding, the posted and actual speed will be listed

Emp/Haz./CMV: Violation occurred and recorded as driving while **Emp**loyed/ carrying **Haz**ardous Material/ in a **C**ommercial **M**otor **V**ehicle. 0 = Unknown, 1 = Yes, 2 = No

Convictions are entered on an Oregon driver record when DMV receives notice from a court or out-of-state jurisdiction that the driver has been convicted of a violation of motor vehicle law.

Restraint Type: SUSP = suspension, REVK = revocation, CANC = cancellation

Withdrawal: If on DMV record prior to July 6, 2020 it will display the suspension or sanction code along with the literal reason of the sanction. If on or after July 6, 2020 it will only display the literal reason of the sanction. A full list of withdrawal types are listed on page 15.

Docket#: The docket or case number from the court

Restraint Start: The date the restraint or suspension started

Jurisdiction: The state or jurisdiction code from which the sanction was submitted

Violation: The date the violation occurred

Restraint Cease: The date the restraint ends

Court Location: The court or agency that ordered the suspension

Offense: The American Association of Motor Vehicle Administrators Code Dictionary, AAMVA ACD code, which is the national standardized codes for each conviction or sanction, along with its literal.

Reinstatement: The date the sanction was reinstated. If blank, the sanction has not been reinstated.

Standard Conviction Abbreviations Table

Below is a list of all conviction types along with the codes that were used prior to July 6, 2020.

Information shown in *SUBSCRIPT* test indicates the entry type is obsolete. Obsolete entry types are no longer used (entered on records), but may still appear on some driving records.

The Standard Convictions Abbreviations table is made up of five columns as follows:

COLUMN 1 (LITERAL)

This column contains the abbreviation (literal) for Oregon convictions. The Oregon literal is a three to twelve character alpha/numeric abbreviation of the offense.

DMV uses ACD codes to record convictions occurring in another state on an Oregon driver. See the ACD Code table (Appendix 3) for definitions and additional information.

COLUMN 2 (CITE)

This column references the Oregon Revised Statutes (ORS) or other citing authority for the offense. The following are examples of the entries found in this column.

807.610 ORS Chapter 807, Section 610

F397.5 Federal Motor Carrier Safety Regulations as contained in Title 49 of the Code of Federal Regulations, Part 397, Section 5.

Local (town/city) Ordinance

COLUMN 3 (CLASSIFICATION)

This column lists the maximum (most serious) classification (class) type and code allowed for the offense. **<u>Note</u>**: The driving record may display a *lesser* class type and code for the offense than the one noted in the table column, but not higher.

<u>COLUMN 4</u> (TEXT)

This column contains a summary of the offense as written in applicable law, regulation or rule.

COLUMN 5 (RETAINED)

Indicates the number of years, from conviction date, the conviction will show on the record.

Note:

- The program to delete record segments is conducted only once a year at the beginning of each year.
- An "*" indicates the retention is 55 years if conviction involved operation of a commercial motor vehicle.
