The proposal must show clear goals and objectives and how they benefit the veterans in your community or Oregon as a whole.
Due to us being government we have many different Departments. Child, Family & Community Connections plans on applying for employment and my Department Clackamas County Social Services Division wanted to apply for separate veterans work Homeless outreach. So we would have to jointly apply or could we apply separately? This is due to separate projects and leadership. What I am seeing we would just have two separate projects?	Only one application will be accepted per Organization. If an organization has multiple departments that want to apply for the grant they must do so jointly on one application. An application may have multiple separate projects that may be implemented by different departments.
