- FEMA Webpages are back online!

  - ✓ Help Desk for PrepToolKit, FEMA SID, Etc.
- NDEMU will be opening back up for training

### **Oregon State Qualifications System**

- Oregon SQS Webpage
- Historical Recognition Process
  - 12 credentialed in ICS Positions
  - 3 credentialed in EOC Skillsets
  - Closing out third QRB review round with an additional 12 individuals
  - 4 applications for next QRB review round
- Began sharing credentialed list with State EMAC Coordinator for mutual aid opportunities
- To use 2020 experience, you must submit application by 12/31/2025
- Historical Recognition Period ends 6/1/2026



### Oregon SQS Historical Recognition Applications

- Process and Guidance:
  - Application/Cover Sheet (with Narrative)
  - Experience Tracker
  - Letter of recommendation from incident supervisor (highly recommended)
  - Training Requirements
    - ICS Positions: Training listed in <u>FEMA RTLT Position Qualification</u>, typically:
      - IS-100, IS-200, IS-700, IS-800, G0191, ICS-300, ICS-400
      - E/L/K course for position specific course
      - O-305: All Hazard Type 3 IMT training course
    - EOC Skillsets: IS-100, IS-700, IS-800, IS-2200, G0191
      - PIO also requires IS-29 and L0105
  - Supporting documentation
    - IAP's identifying you in the position
    - ICS-225 evaluations from an event
  - EOC Skillset Checklists and PTB's are not required for HR
- Finished HR application packets submitted to <u>oem.training@oem.oregon.gov</u>

### **Instructor Development**


- Oct. 27-31: N-310: O-305 Train-the-Trainer at OEM with 24 Instructors
