Oregon State Qualification System Webpage

- Historical Recognition Process
 - 18 credentialed in Type 3 ICS Positions
 - 9 credentialed in EOC Skillsets
 - Just closed out third QRB review round.
 - 10 more applicants for Round 4 review starting after the holidays
- To use 2020 experience, you must submit application by **12/31/2025**

Historical Recognition Period ends 6/1/2026



Oregon SQS Historical Recognition Applications

- **Training Requirements**

- **ICS Positions:** Training listed in [**FEMA RLT Position Qualification**](#), typically:

- IS-100, IS-200, IS-700, IS-800, G0191, ICS-300, ICS-400
- E/L/K course for position specific course
- O-305: All Hazard Type 3 IMT training course

- **EOC Skillsets:** IS-100, IS-700, IS-800, IS-2200, G0191

- PIO also requires IS-29 and L0105

- [Process and Guidance](#):

- Application/Cover Sheet (with Narrative)
- Experience Tracker
- Letter of recommendation from incident supervisor (highly recommended)
- Supporting documentation
 - IAP's identifying you in the position
 - ICS-225 evaluations from an event
- [EOC Skillset Checklists and PTB's are not required for HR](#)
- [Starting June 1st 2026, Task books are required](#)

- Finished HR application packets need to be submitted to oem.training@oem.oregon.gov




Integrated Preparedness Planning

State Training Program Update

- End of the Calendar Year
 - 96 Trainings held in Oregon
 - 74 G-Courses
 - 22 AWR, PER, MGT, or L courses
- O-305 Instructor Cadre Development
 - Held train the trainer course in October
 - 22 Oregon Instructors in Salem N-310 + 3 more went to NETC
 - DPSST and OEM Training collaborating on state endorsed instructor pathway.
 - Submitted to NFA for alignment and approval



ICS 300/400 Clarity

- [NIMS](#) Update in 2017 (Third Edition)
- ICS 300 and ICS 400 (2019 versions) are replacements for the 2013 versions. If you have successfully completed a previous version of these courses, there is no official FEMA requirement to take the revised version of the course.
- However, because these courses contain new information based on the Third Edition of NIMS (October 2017), newer and higher-level courses may require the student to take the latest version. This will be clearly defined on the [NTED](#) information regarding prerequisites.

Prerequisites

Endorsement from the State Training Officer or equivalent is required for State, Territorial, Tribal and Local the-Trainer course.

Participants must have successfully completed (the most current version(s)):

- ICS 0100 (IS-0100), Introduction to the Incident Command System;
- ICS 0200 (IS-0200), Basic Incident Command System for Initial Response;
- ICS 300 (E/L/G0300), Intermediate Incident Command System for Expanding Incidents;
- ICS 400 (E/L/G0400), Advanced ICS for Complex Incidents;
- IS 0700, National Incident Management System, An Introduction;
- IS 0800, National Response Framework, An Introduction;
- ELG 0191, Emergency Operations Center/ICS Interface
