AWR-132: Understanding and Planning for School Bombing Attacks......Homestead 2

New Mexico Tech Energetic Materials Research and Training Center

Participants are presented with information necessary to recognize a threat and determine pre- and post-detonation threat response strategies and develop actionable items specific to an individual's school needs.

The National Preparedness Goal calls for emergency managers to engage the "whole community" in preparedness planning. However, whole-community preparedness can be a difficult goal to achieve due to a lack of buy-in from community members, strained budgets, and limited staff bandwidth. Using data gathered through a case study of seven college and university emergency management offices, the presenter will describe the obstacles created by "the three B's" and share best practices to overcome these barriers based on the study's findings.

Incident Mapping and Evacuation Management on a Time and Money Budget......Landmark

This session will provide an overview of some low and no-cost options for creating and publishing incident maps for evacuation management and public notification. It will focus on best practices for organi zing maps and delineating evacuation boundaries on expanding incidents, moving information between common programs (such as Google Earth, SARTopo, Genasys, and Everbridge), and various options for taking information from an initial report to a basic map and then communicating with the public using IPAWS and/or social media.

Many emergency managers recognize the importance of accessibility and the need to support community members of people with disabilities in emergency planning. Emergency management must be informed by the diverse experiences of people with disabilities to create truly inclusive preparedness, response, and recovery efforts. The Disability and Emergency Management Advisory Council (DEMAC) plays a critical role in identifying systemic barriers and advocating for solutions that improve accessibility in disaster planning. This session will explore key insights from Oregon's disability community, focusing on lessons learned from wildfire evacuations and broader emergency management challenges. DEMAC leadership will share practical strategies to bridge gaps in planning, ensuring a more equitable and effective emergency response for all.

A panel discussion with representatives from Deschutes County and the Oregon Department of Human Services' Office of Resilience and Emergency Management will share how this multidisciplinary team transformed a drawing board idea into an integral part of our evacuation operations.

This resulted in severe property damage, displaced 40 employees, reduced public services, and took 10 months to repair and reopen.
