No more evacuations, water continues to rise along Fast River causing flooding to low lying areas. ARC shelter open at ABC Church with 100 people (capacity of 200). Retirement home evacuated to Fair Grounds. Small City is monitoring their reservoir, still have 1 ft to go before capacity. Public Works requested an engineer from WRD to come inspect. Big City has numerous road closures, monitoring of Wide Creek continues. County is monitoring the Wet River as well.
