It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Making a False Claim for Health Care Payment

Count number 1, Making a False Claim for Health Care Payment, 165.692, Felony Class C, committed on or between 10/17/2016 and 12/01/2016. Conviction is based upon a Guilty Plea on 02/12/2018.

Sentencing Guidelines

The Crime Severity Classification (CSC) on Count Number 1 is 6 and the Criminal History Classification (CHC) is I.

Probation

Defendant is sentenced to Supervised Probation for a period of 36 month(s) and shall be subject to the following conditions of Probation: Defendant is ordered to pay a supervision fee.

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- The Court imposes the general conditions of probation listed in ORS 137.540. Probation Officer shall review the standard conditions of probation with the defendant.
- Report to Deschutes County Community Corrections, Parole and Probation, 63360 Britta Street Bldg.# 2 Bend, Oregon 97701, no later than 4pm 3/2/18, and report thereafter as directed by defendant's probation officer.
- Complete 100 hour(s) community work service on a schedule agreed upon by PO.
- Continue with Mental Health treatment and sign a release for PO to access records as needed.
- Defendant is not allowed employment compensated by Medicaid or Medicare dollars.

Probation

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)):
Defendant shall:

- Concurrent to count 1 and count 2. Same terms and conditions as listed in count 1.
