



APAC Data Submission Schedule starting January 2024

1. Submissions are due on or before the dates listed below.
2. If a submitted file requires correction, OHA rule allows for a 14-day correction period to work with the APAC data vendor (HSRI) to correct the errors. If errors cannot be corrected within the 2-week grace period, the mandatory reporter must submit a request an exemption from the validation rule or an extension to avoid a civil penalty.
3. APAC reporting is required by law and highly predictable in content and timing. Therefore, insufficient resources to comply with reporting required by law will not be an acceptable reason for non-compliance.
4. Mandatory reporters that have not correctly submitted data and have not been approved for an exemption or extension 14 calendar days after the submission date will be considered non-compliant. OHA may take action to impose civil penalties as outlined in OAR 409-025-0150.
