

# Behavioral Health Resource Network Data


## HPA Data Profile

**Behavioral Health Resource Networks (BHRNs)** are comprised of community-based providers that provide timely, low-barrier access to substance use disorder treatment, harm reduction, and recovery support services for people at risk of overdose or substance-related harm. BHRN providers (called “grantees” from here forward) receive grant funding from OHA to deliver support where other funding, like Medicaid, leaves gaps in the continuum of care. 
BHRN grantees report data to help evaluate the impact the program is having on substance use disorder treatment statewide.

# Regular reporting

OHA publicly reports the data collected from BHRN grantees through an interactive [BHRN Program dashboard](#). The dashboard allows users to explore data by service area and county for topics including:

- The total number of service encounters that occurred each quarter
- Client demographics (race/ethnicity, age, and gender identity)
- Qualitative data describing successes and challenges experienced by grantees
- Total amounts of funds allocated to and spent by grantees

The BHRN Program is updated quarterly and covers the first three years of the program (known as Grant Cycle 1) through June 2025.

With the start of a new grant cycle (Grant Cycle 2) in July 2025, OHA is preparing a new BHRN Program dashboard. This data profile will be updated in when the new dashboard is published (expected by late spring 2026).

## About the data

This section includes information about where BHRN data come from, the types of information available, and important things to know when interpreting the data.

### Overview of data collection and data elements

Every BHRN grantee submits quarterly reports to OHA with information on the services they provided. Calendar year 2025 saw a transition of BHRN grant cycles, with the end of Grant Cycle 1 (2022-2025) and the start of Grant Cycle 2 (2025-2029). While the core reporting requirements remain largely consistent in both grant cycles, the quality of the data OHA receives from grantees will improve in Grant Cycle 2 with the launch of new reporting systems.

**During Grant Cycle 1 (2022-2025) BHRN grantees reported on programmatic-level data in aggregate.**

During the first grant cycle, grantees submitted data through a program called Qualtrics. Data elements available during Grant Cycle 1 included:

- Number of clients served (by service area)
- Client demographics (race, ethnicity, age, gender)
- Number of individuals denied or not connected to services
- Narrative portions describing successes, challenges, notable expansion of services, reasons for service denials
- Harm reduction and outreach activities

**Grant Cycle 2 introduces new data reporting platforms which will provide a more comprehensive view of BHRN operations, service delivery, and outcomes.**

Two complementary platforms will be used to collect data from BHRN grantees during the second grant cycle: 1) Submittable and 2) Resilience Outcomes Analysis and Data Submission (ROADS).

**Data elements collected from BHRN grantees through the Submittable reporting platform include:**

- Number of clients receiving comprehensive behavioral health needs assessments
- Aggregated data on peer support services, including number of clients who receive peer support services three or more times in a quarter
- Quarterly expenditures by service area and standardized budget categories
- All staffing supported in whole or part by grant funds
- Data on culturally and linguistically specific services, including populations served and staff who identify with belonging to served communities
- Harm reduction data, such as distribution of supplies and individuals engaged in services
- Denials and referral patterns
- Utilization of telehealth services
- Outreach efforts
- Narrative updates describing successes, challenges, feedback, and/or media links to complement data reported each quarter.

**Grantees providing SUD treatment, peer support, screening, and housing services are also required to report data into a second reporting platform called ROADS.** In addition to client-level data, ROADS will collect service-level details. These details are specific to each service area and include information such as:

- Types of housing provided
- Services provided in a peer encounter
- Screening outcomes
- The form of SUD treatment received
- Client's need for wraparound services and the fulfillment of these services
- Information at the end of a client's episode of care and the reason their services ended.

*Note: Due to technical integration and provider readiness, the compliance date for all BHRN grantees to begin reporting into ROADS is July 2026, with an extension period until November 2026.*

## **Timing and frequency**

### **Data submission**

BHRN grantees submit data to OHA on a quarterly basis, with the due date falling the month after each three-month period when services are performed. For example, grantees submit data in April for period covering January through March.

### **Data publication**

OHA must validate each data submission and update the data dashboard, which takes an additional two months. As a result, **there is a three-month lag between the delivery of services and publication of data.** For example, the BHRN dashboard will be updated in June with data from January through March.

### **Grant Cycles**

- Grant Cycle 1: July 2022 - June 2025 (3 years total)
- Grant Cycle 2: July 2025 - June 2029 (5 years total)

As described on the previous page, the data submitted through the ROADS platform will not be available from all BHRN grantees until mid-late 2026. As a result, the first quarter of complete Grant Cycle 2 data will be published in early 2027.

## REALD and SOGI

### What are REALD and SOGI?

REALD and SOGI are types of standardized demographic information. REALD stands for: Race, Ethnicity and Language, Disability. SOGI stands for: Sexual Orientation and Gender Identity. Collecting and analyzing data aligned with REALD and SOGI standards help us identify and address health disparities, and support data justice in communities that are most affected by health disparities. ### REALD and SOGI in BHRN data

The new client-level data collected through the ROADS platform beginning in mid-late 2026 is expected to be compliant with REALD and SOGI standards. While demographics such as race, ethnicity, age, and gender identity questions were modeled after REALD/SOGI methods in Grant Cycle 1, data collected in this cycle were not REALD/SOGI compliant largely due to aggregate data collection.

### Things to remember when using Measure 110 BHRN data...

- Aggregated client counts reported through Submittable can and likely will contain duplicates. There is no way to ensure that a client is not reported by more than one BHRN grantee in a quarter.
- Aggregated client counts reported through Submittable cannot be summed across service areas to arrive at a single client count.
- BHRN grantees provide a wide array of different services, even within a BHRN-funded service area (i.e. harm reduction or housing). Quantitative data, such as client counts or the number of encounters, should not be used in isolation to evaluate the impact of a BHRN grantee's program.
- BHRN grantees can, and often do, update their reporting. Values presented on BHRN Program dashboards are subject to change, even for previous quarters.

### A brief history of the BHRN Program

BHRN services are funded through the Drug Treatment and Recovery Services Fund (DTRSF). The DTRSF was established by the passage of Ballot Measure 110 (2020), which created the Measure 110 (M110) Program and supported the initial development of Behavioral Health Resource Networks to provide statewide, low-barrier substance use disorder treatment and recovery services.

Measure 110 has since been amended through [SB 755 \(2021\)](#), [HB 2513 \(2023\)](#), and [HB 4002 \(2024\)](#) to refine BHRN implementation and impact on the broader behavioral health system. **In October 2025, the M110 Program was retired and updated to the BHRN Program**, enacted through the most recent BHRN amendment with the passage of [SB 610 \(2025\)](#), which transitioned BHRN administration from the Oversight and Accountability Council (OAC) to the Oregon Health Authority
