  - b. Nursing;
  - c. Laboratory;
  - d. Pharmacy; and
  - e. Dietary; or
- (B) A special inpatient care facility as that term is defined by the authority by rule

#### **Reportable Affiliated Clinic:**

An outpatient clinic located in Oregon that is:

- (A) Is operating under the common control of a hospital; or
- (B) Is owned in whole or part by the hospital; or
- (C) Is operating under the same brand of the hospital
