

**Hospital Community Benefit Minimum Spending
Floor Comment Periods**

As stated in rule [409-023](#), for 30 days after the Oregon Health Authority notifies a hospital or health system of its proposed community benefit minimum spending floor, members of the public may provide comments on the minimum spending floor while the hospital or health system may formally request a modification to the spending floor.

The following table lists the **expected** comment period for each hospital in Oregon; however, these dates are not certain and may be later than stated in the table. The comment period will never be earlier than the start date in the table. **The comment period will always last 30 days.**
