3. Oregon Rural Practice Research Network at OHSU (ORPRN)

ORPRN is providing technical assistance and expertise on social needs screening in Oregon for this project. They have been working since February 2020 to 1) Conduct and Environmental Scan of the existing social needs screening efforts in Oregon (of government partners, CCOs, health systems and community organizations), and 2) Compile peer-reviewed journal articles relevant to the topics the

workgroup will be exploring. Links to both efforts are shared here. ORPRN also has a grant from the Centers for Medicare and Medicaid Services to implement the Accountable Health Communities project, a social needs screening model; however, ORPRN took a neutral evidence-based approach to conducting the research, interviews and survey below.
