Member Biographies

F. Douglas Carr, MD, MMM

Dr. Carr joined Umpqua Health Alliance in July 2107 as Medical Director of the CCO that serves Douglas County. His prior experience in the Northwest includes leadership roles at PeaceHealth Medical Group and the Eugene VA Healthcare Center.

Dr. Carr previously worked for 24 years at Billings Clinic (Montana), where he served in various clinical and management roles in regional operations and education. His diverse experiences there include leadership responsibilities in the first Medicare ACO demonstration, regional telemedicine program, FM and IM residencies, FQHC, public health, provider-sponsored health insurance, as well as statewide PCMH initiatives and state employee pharmacy plan.
