

Background: HB3261

- In 2017, Legislature passed HB3261 which consolidated multiple state programs into a single program effective 1/2/2018, with various incentives available. The legislature initially created several "buckets" of funding for specific incentive types:
 - Loan Repayment (\$4.0m)
 - Loan Forgiveness/Scholarships (\$7.1m)
 - Insurance Subsidies (\$4.0m)
 - Other (\$1m)





New Rules for a New Program

- The Health Care Provider Incentive Program was created to replace and surpass the various programs that had been separately in existence. Modifications from previous programs include:
 - Naturopaths and Pharmacists included as eligible providers
 - Made awards available to Behavioral Health clinicians working toward licensure
 - Loan repayment incentive available to providers already practicing at eligible practice sites less than two years
 - Secondary language skills and cultural agility included in the award determination criteria for loan repayment






What's Happened Since the Start of the Program?




Loan Repayment

- \$4,000,000 earmarked
 - Program awarded 83 clinicians a total of \$3.7 million, or 92% of the budget.
 Loan Repayment Budget Spent



- Of those awarded:
 - 46 working in Rural areas (55%)
 - **37** working in non–Rural (aka "Urban Underserved") areas (44%)







"SHOI-Like" Scholarships

- Program made available:
 - \$336,000 in scholarship funds to Western University of Health Sciences- College of Osteopathic Medicine of the Pacific (COMP-NW) (3 scholars)
 - \$269,000 in scholarship funds to National University of Natural Medicine (NUNM) (4 scholars)
- Pacific University will launch its "SHOI-Like" Scholarship opportunities for the 2020 school year
- Students who accept these awards will be required to work at a qualified site *in Oregon*




Rural Malpractice Insurance Subsidy

- Eight different insurance carriers participate:
 - » Affinity Insurance Services Inc. (CNA)
 - » Oregon Medical Association Group (CNA-OAN)
 - » Coverys/ProSelect
 - » Darwin National Insurance Company
 - » Preferred Professional Insurance Company
 - » The Doctors Company
 - » Physicians Insurance Company
 - » Medical Protective Services
- Since January 2018, the Program has awarded more than \$3.7 million in medical malpractice premium subsidies to over 550 physicians and nurse practitioners in rural practice settings
- Subsidies range from \$109.69 to \$12,860.00
- Average subsidy is approximately \$997




Rural Malpractice Insurance Subsidy Map




Effects on Workforce Capacity

- Since the beginning of the HCPIP, Primary Care provider FTE has increased in the following service areas:
 - » North Lake
 - » East Klamath
 - » Cave Junction
 - » Glide
 - » Drain/Yoncalla
 - » Veneta
- Additionally, an analysis of 2018 Areas of Unmet Healthcare Needs Report indicated:
 - » Many of the areas with workforce declines had increased FTE
 - » Of the 16 highest-need areas identified in 2017, seven of those areas are no longer in bottom quartile of service areas
 - » The lowest scoring area in the state improved its score from 19 to 20







Summary

- Oregon Health Authority allocated \$14 million for 2017-19 for HCPIP
 - Over \$12.5 million spent/obligated!
 - An additional \$3 million allocated directly to OHSU for SHOI, PCLF
 - More than 737 clinicians funded
 - 32 students funded with scholarships/loan forgiveness
 - 115 additional FTE supported through these funds (current and future years)



So, What's Next?

- 2019-21 Allocation:
 - \$17.6 million
- Back to Workforce Committee in September with recommendations
