

### Provider Organizations Required to Submit Frontline Worker Compensation Data (CGT-4) 2025

Provider organizations with 10,000 or more attributed patients, or 120,000 attributed member months, in at least one market (Medicare Advantage, Medicaid, Commercial), as identified in the [2024 Sustainable Health Care Cost Growth Target Annual Report](#) for both the 2021 and 2022 measurement years are required to submit frontline worker compensation data (CGT-4) to OHA for the 2025 data submission cycle.<sup>1</sup>

## Voluntary Submission of Frontline Worker Compensation Data (CGT-4) 2025

Provider organizations identified in the [2024 Sustainable Health Care Cost Growth Target Annual Report](#) who do not have 10,000 or more attributed patients, or 120,000 attributed member months, in both measurement years are not required to submit frontline worker compensation data, but may choose to provide this data to OHA voluntarily. Federally Qualified Health Centers (FQHCs) and provider organizations primarily serving pediatric populations are also voluntary reporters, even if they have 10,000 or more attributed patients in the annual report.<sup>1</sup>
