² According to Oregon Administrative Rule (OAR) 409-065-0010, mandatory submitter status is based on data from DCBS for the Medicare Advantage line of business. For Aetna, the data reflected in the table for Medicare Advantage were taken from enrollment data from the Centers for Medicare and Medicaid Services (CMS). This is because DCBS data for Aetna's Medicare Advantage line of business are incorrect. Aetna reaches the threshold to be a mandatory reporter for the program regardless of its Medicare Advantage enrollment.

Voluntary Reporters

Voluntary reporters are payers and licensed third-party administrators invited to submit data to Oregon's Cost Growth Target program.

Voluntary reporters include payers with at least 1,000 covered lives in the commercial: self-insured market in Oregon identified in the 2023 DCBS enrollment data and payers solely providing Medicare Advantage plans with covered lives representing less than 5 percent of the total Medicare Advantage market in Oregon. Payers that have both fully-insured and self-insured plans in Oregon are included in the Mandatory Reporters above.

Voluntary reporters highlighted in gold are invited to submit data but will not be identified individually in any public reporting. Their data will be reported in aggregate at the state and market levels only.
