Ua ke Kroger thiab Albertsons

[Health Care Market Oversight](#) (HCMO) tshuaj xyuas txhua yam kev lag luam ntsig txog kev pab kho mob, xws li kev sib koom ua ke ob lub lag luam thiab kev yuav lwm lub lag luam, kom paub tseeb tias lawv tsis cuam tshuam rau tib neeg thiab cov zej zog hauv Oregon txoj kev phem. Thaum Lub Yim Hli 8, 2023, Oregon Health Authority (OHA) tau txais [ntawv ceeb toom](#) uas tau hais tias Kroger tau yuav Albertsons. Daim ntawv ceeb toom piav qhia txog cov phiaj xwm rau ob lub tuam txhab sib koom ua ke.

Leej twg koom nrog?

Kroger yog ib lub tuam txhab pej xeem uas khiav lag luam loj hauv 35 lub xeev hauv ntau lub npe, suav nrog Fred Meyer thiab QFC. Kroger yog lub tebchaws loj tshaj plaws ntawm cov khw muag khoom loj. Feem ntau cov khw muag khoom ntawm Kroger suav nrog cov khw muag tshuaj, suav nrog 53 lub tsev muag tshuaj me hauv Oregon uas nyob hauv Fred Meyer thiab QFC cov khw muag khoom. Kroger kuj muaj kev lag luam los tswj cov kev pab ntawm cov khw muag tshuaj thiab muaj lub khw muag tshuaj uas tuaj yeem xaj tshuaj los ntawm kev xa ntawv.

Albertsons yog ib lub tuam txhab pej xeem uas khiav lag luam loj hauv 34 lub xeev hauv ntau lub npe, suav nrog Safeway, Albertsons thiab Sav-On. Feem ntau cov khw muag khoom loj uas muaj los ntawm Albertsons muaj cov chaw muag tshuaj me me ntawm qhov chaw, suav nrog 106 lub khw muag me me hauv khw hauv Oregon. Albertsons tseem muaj cov kev pabcuam kev noj qab haus huv nyob deb hauv kev koom tes nrog Providence Health and Services.

C&S Muag Khoom Muag Khoom Muag (“C&S”) yog ib lub tuam txhab ntiag tug tsom rau cov khoom lag luam wholesale. C&S muab ntau txhiab lub khw muag khoom ywj pheej thiab me me. Nws tseem ua haujlwm cov khw muag khoom me me hauv Midwest xeev thiab Carolinas.

Hais txog kev sib tham ua lag luam

Kroger yuav them \$ 24.6 nphom los yuav Albertsons. Los ntawm kev sib tham ua lag luam, Kroger yuav siv \$4.7 nphom ntawm Albertsons cov nuj nqis. Ob lub tuam txhab hais tias lub hom phiaj ntawm kev yuav khoom yog los tsim kom muaj kev sib tw ua ke ntau dua. Hauv tsab ntawv ceeb toom, Kroger hais tias nws tsis muaj kev npaj txo cov kev pabcuam cuam tshuam txog kev pab kho mob lossis chaw muag tshuaj hauv Oregon. Txhawm rau hais txog kev txhawj xeeb los ntawm xeev thiab tsoomfwv cov tub ceev xwm hais tias kev sib koom ua ke tuaj yeem txo qis kev sib tw khoom noj khoom haus, ob lub tuam txhab npaj yuav muag (“divest”) ntau dua 400 lub khw muag khoom ntawm Albertsons thiab Kroger rau C&S, suav nrog 49 lub khw hauv Oregon.

Tom ntej no yog dab tsi?

OHA tab tom tshuaj xyuas qhov kev sib tham ua lag luam no kom nkag siab tias nws tuaj yeem cuam tshuam li cas rau kev saib xyuas tsev muag tshuaj thiab nkag mus rau cov tshuaj noj rau cov zej zog hauv Oregon. Thaum lub sijhawm tshuaj xyuas, OHA yuav siv 'kev saib xyuas kev noj qab haus huv' cov ntaub ntawv, xov xwm thiab xov xwm tshaj tawm, cov ntaub ntawv los ntawm cov tuam txhab, thiab cov tswv yim los ntawm pej xeem los txiav txim siab pom zoo rau qhov kev lag luam no lossis tsis. Tom qab ua tiav qhov kev tshuaj xyuas, OHA yuav txiav txim siab yog tias kev lag luam yuav tsum ua raws li tau npaj tseg lossis tsis ua. Qhov kev lag luam no tseem nyob rau hauv kev tshuaj xyuas los ntawm tsoomfwv thiab lub xeev cov tswj hwm.
