1. <u>Facility Locations and Status</u>. Since November 3, 2023, the following new facility was acquired:

River Road Surgery Center, LLC 3099 River Road S Ste 100 Salem, OR 97302

• Acquisition Date: July 1, 2024

There have been no facility closures, planned construction, or planned purchases of new facilities in Oregon directly or indirectly owned by Ambulatory TopCo, LLC, AmSurg Holdco, LLC, AmSurg, LLC, or AmSurg Holdings, LLC.

- 2. <u>Operational Structure Changes</u>. There have been no changes to the operational structure of the five ambulatory surgery centers (ASCs) located in Oregon since November 3, 2023.
