This Plan of Conversion (this "Plan") provides for the conversion of Primary Health, Inc. (the "Corporation") from a Delaware corporation to an Oregon corporation to be known as PacificSource Asssurance, Inc. (the "Converted Corporation") pursuant to the provisions of ORS 60.472 and DGCL §266 and in accordance with this Plan (the "Conversion").

## Recitais

- The Corporation is a corporation duly organized and existing under the laws of Delaware ¹ А. and is a wholly owned subsidiary of PacificSource Health Plans, an Oregon non-profit corporation (the "Shareholder").
- 8. The Board of Directors and the Shareholder deem it advisable and in the best interest of the Corporation that the Corporation be converted into an Oregon corporation and thereafter exist as an Oregon corporation pursuant to ORS chapter 60.
- C. The Board of Directors of the Corporation has adopted, and the Sole Shareholder has approved, the Plan.

NOW, THEREFORE, the Corporation shall be converted and reorganized as an Oregon corporation upon the following terms and conditions.

## Plan

- Entity Before Conversion. The name of the entity before conversion is Primary Health, Inc. The type of the entity before conversion is a Delaware corporation.
- Entity After Conversion. The name of the entity after conversion is PacificSource Assurance, Inc. The type of the entity after conversion is an Oregon corporation.
- Effective Date. The Articles of Conversion and any other documents necessary to be filed to effectuate the conversion will be filed with the Oregon and Delaware Secretaries of State and the conversion will be effective on the date of the filing of the Articles of Conversion (the "Effective Date").
- Terms and Conditions of Conversion. On the Effective Date, Primary Health, Inc. will convert from 4. a Delaware corporation to an Oregon corporation, and the name of the converted entity will be PacificSource Assurance, Inc.
- Certificate for Shares. Each certificate that, before the Effective Date, represented shares of common stock of the Corporation, from and after the Effective Date, will represent shares of common stock of the Converted Corporation.
- 6. Board of Directors. As of the Effective Date, the current members of the PacificSource Board of Directors shall become the Board of Directors of the Converted Corporation.

- 7. Officers. As of the Effective Date, the current Officers of PacificSource shall become the Officers of the Converted Corporation.
- 8. **Bylaws.** The Bylaws of the Corporation in effect immediately before the Effective Date will be the bylaws of the Surviving Corporation until amended or repealed.
- 9. Effect of Conversion.
  - As of the Effective Date, all of the rights, privileges, obligations, liabilities, and duties of the Corporation; all property of the Corporation, whether real, personal, or mixed; all debts of whatever nature owed to the Corporation; and all other things and causes of action of the Corporation shall be vested in the Converted Corporation and thereafter attach to the Converted Corporation without further notice or action.
  - 9.2 The Corporation shall not be required to wind up its affairs, pay its liabilities, or distribute its assets. The Conversion shall constitute a continuation of the existence of the Corporation in the form of the Converted Corporation.
  - 9.3 The Corporation and the Converted Corporation shall be the same entity.
