- 1. I am Larry Kirsch and an economist in Portland. I am unaffiliated. I've spent many years focusing on consumer protection in the healthcare sector and have worked extensively in regulatory proceedings not dissimilar to this one.
- 2. Having reviewed the file, my conclusion is the Review Panel does not have the raw materials needed to make a critical analysis of costs and cannot make credible recommendations to OHA as contemplated in the statute.
- 3. The Applicants claim that synergies and efficiencies will keep costs down. They fail to consider the effect of added bargaining leverage on insurance premiums. Without access to the basic assumptions, data, and analysis, and the ability to ask follow-up questions, those assertions are highly questionable. I've seen the same narrative time and again only to see results that veer completely off course.
- 4. I would respectfully ask whether the Parties are willing to fully un-redact all the exhibits including Q 15-Exh 3 and Q7 Exh 4 &5 relating to costs and cost estima
