Reference is made to that certain System Combination Agreement, dated as of May 30, 2024 (the “**Agreement**”), entered into by and between Oregon Health & Science University, an Oregon statutory public corporation, and Legacy Health, an Oregon nonprofit corporation (“**Legacy Health**”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Agreement.

These Disclosure Schedules are qualified in their entirety by reference to specific provisions of the Agreement. Except as expressly noted herein, inclusion of information herein shall not be construed to imply or admit that such information is material to the business, operations, or financial condition of Legacy Health, or to the transactions contemplated in the Agreement, or that such information meets any applicable materiality threshold, nor shall inclusion of such information herein be construed as an admission or indication that any breach or violation of any agreement or law exists or has actually occurred. In addition, no dollar amount referenced herein or in the Agreement is intended to imply what is or is not material.

The information set forth in one section or subsection of these Disclosure Schedules shall be deemed to apply to each other section or subsection hereof to the extent that: (a) its application is reasonably apparent on the face of the disclosure (without reference to any independent knowledge on the part of the reader regarding the matter disclosed) or (b) such section or subsection is specifically incorporated by reference. 2. Provide notice of the Transactions to the Washington State Attorney General (the “**WAG**”) as required by the WAG, and any supplemental information requested in connection therewith.
3. Either (a) obtain a certificate of need approval from the Washington State Department of Health with respect to the Transactions or (b) obtain a determination from the Washington State Department of Health that the Transactions are not subject to review.
4. With respect to the material Environmental Permits (certain of those items set forth at Section 4.7.1), any administrative updates necessary to reflect site name changes pursuant to Section 3.3 of the Agreement.
5. Centers for Medicare & Medicaid Services (“**CMS**”), Medicare Part A and B Enrollments held by Legacy Health Entities as described on Attachment 4.8.1 (submit enrollment updates to reflect updated ownership/control information within 30 days post-closing).
6. State Medicaid Enrollments held by Legacy Health Entities as described on Attachment 4.8.1 (submit enrollment updates within 35 days post-closing, or as otherwise required by each respective state’s processes, to reflect updated ownership/control information).
7. Obtain consent from Cayman Islands Monetary Authority (“**CIMA**”) for the Transactions to the extent required regarding OHSU’s assumption of Legacy Health’s ownership interest in Legacy Health System Insurance Company.
