I am writing in opposition to this proposed acquisition. The loss of Northwest Gastroenterology will have a devastating effect upon patient care and the choices of providers to the residents of Portland. First, please review litigation regarding Oregon Clinic's past patient care and that which is currently pending. Secondly, please consider the disposition of gastroenterology providers in Portland, and the insurance ""network"" affiliations to the hospitals in Portland subscribe. Oregon Clinic controls an overwhelming majority of the available providers in the Portland such that their market share of all specialties is disproportionately large. At the same time over the recent past, their quality of care and attention to detail has been disastrous. Permitting the loss of NW Gastroenterology's Independence would be a terrible disservice to the people of Portland and beyond, please reject it.
