## ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS, That Rickar D. Watkins and

Donna L. Watkins

a natural person, or if more than one, each a natural person of the age of eighteen years or more, do hereby incorporate a corporation under and pursuant to the laws of the State of Oregon relative to private corporations and hereby do adopt, execute and verify, in duplicate, the following ARTICLES OF INCORPORATION thereof:

## ARTICLE I.

The name of the corporation is Rick's Medical Supply, Inc.

and the duration thereof shall be perpetual.

## ARTICLE II.

The purpose or purposes for which the corporation is organized shall be:

(1) To engage in any lawful activity for which corporations may be organized under Chapter 57 of Oregon Revised Statutes;

(2) To engage in the sales and rentals of medical supplies and equipment

Lastly, to do any and all other acts and things necessary, incident, proper, desirable or convenient for carrying out the purposes of this corporation or any of them, and generally to engage in any or all of the foregoing enterprises, businesses and occupations, either within or without the State of Oregon or the United States.

The foregoing enumeration of powers is not intended and shall not be held to limit or restrict in any manner the general powers of this corporation under the laws of the State of Oregon.

NOTE:

See the Oregon Business Corporation Act in Chapter 57 of Oregon Revised Statutes, which provides that one or more natural persons of the age of eighteen years or more, may act as incorporator or incorporators of a corporation by signing, verifying and delivering, in duplicate, to the Corporation Commissioner of the State of Oregon, Salem, Oregon, articles of incorporation for such corporation (ORS 57.306) and that one or more directors are required. (ORS Section 57.185).

Space is provided in Article VI of the form for setting forth the par value of each share of stock or the fact that shares are without par value, as well as information as to different classes of stock if there are to be more than one, and in Article VIII for setting forth any provision not inconsistent with law for the regulation of the internal affairs of the corporation.
