ARLOZOROV9, INC., a corporation organized and existing under and by virtue of the provisions of the Delaware General Corporation Law (such corporation, the “*Company*,” and such law, the “*DGCL*”), hereby certifies that:

FIRST: The name of this corporation is **ARLOZOROV9, INC.**

SECOND: The date on which the Certificate of Incorporation of the Company was originally filed with the Secretary of State of the State of Delaware was November 16, 2017.

THIRD: The Board of Directors of the Company (the “*Board*”), acting in accordance with Section 141 and Section 242 of the DGCL, adopted resolutions amending the Amended and Restated Certificate of Incorporation of the Company (the “*Certificate*”) as follows:

The first paragraph of Article Fourth of the Certificate shall be amended and restated to read in its entirety as follows:

“The total number of shares of all classes of stock that the Corporation will have authority to issue is (i) 50,000,000 shares of Common Stock, \$0.0001 par value per share (“*Common Stock*”) and (ii) 28,985,600 shares of Preferred Stock, \$0.0001 par value per share (“*Preferred Stock*”).”

FOURTH: Thereafter pursuant to a resolution of the Board, this Certificate of Amendment was submitted to the stockholders of the Company for their approval, and was duly adopted in accordance with Section 228 and Section 242 of the DGCL.
