

About Oregon's Health Care Market Oversight Program

Through the **Health Care Market Oversight (HCMO)** program, OHA reviews proposed health care business deals to make sure they support statewide goals related to cost, equity, access, and quality.

HCMO aims to...



Promote transparency



Support statewide priorities



Monitor and study impacts

What authority does OHA have?

For each proposed deal that is reviewable, OHA may:

- Approve
- Approve with conditions
- Disapprove

For deals that involve a domestic health insurer, OHA provides a recommendation to the Division of Consumer and Business Services, who makes the final decision.



HCMO Review Process

Very high level

Health care entities file notice that they are planning a reviewable transaction

HCMO reviews the transaction and its potential impacts

HCMO invites public comment and may engage other experts

HCMO issues decision

HCMO conducts follow up review 1, 2 and 5 years after closing

During reviews, HCMO looks at how a proposed transaction could affect:



Health care costs



Access to care



Quality of care



Health equity



Market consolidation

Rules Advisory Committee (RAC) Process

About Rules Advisory Committees

A RAC is used to seek input to the maximum extent possible during the development of the proposed rulemaking prior to giving notice of intent to adopt, amend, or repeal an administrative rule.

A RAC allows the public and interested parties to provide input and suggestions during the development of new rules, amendment or repeal of existing rules, and the fiscal impact of the proposed rulemaking. The RAC's role is advisory, and consensus is not necessary.

The Oregon Health Authority (OHA) is holding this RAC meeting as public meeting and any individual is welcome to attend, observe, and listen. The RAC meeting will include a time for the public to provide comment.

Previous HCMO Rulemaking

2021	Initial rulemaking after establishing legislation.	
2022	Rule changes to add / clarify definitions, details about Community Review Boards, and the 2023 fee schedule	
2024	Rule changes to clarify in-state / out-of-state entities, when emergency exemption requests are made public, and other primarily housekeeping changes.	

Developing proposed rule changes for 2025

- HCMO gathered input from the public through:
 - Ongoing public comment
 - Two listening sessions in September 2025
 - Oregon Health Policy Board conversations and public comment

 HCMO also reviewed public comments that were suggested during the 2024 rulemaking process.

Feedback to-date

For today's RAC meeting, HCMO has provided a summary of all feedback and suggested rule changes received todate, along with notes about how the input has been addressed.

Categories:

- Incorporated
- Partly incorporated
- Not incorporated feedback

Note: a substantial number of comments and suggestions that HCMO has received to-date would require statutory change and cannot be addressed through administrative rulemaking.

Other suggestions may be more appropriate for sub-regulatory guidance.

Clarify language regarding in- and out-of-state entities, including clarifying parameters for when an entity may be considered out-of-state.

409-070-0020 Excluded Transactions

409-070-0022 Emergency and Exempt Transactions

OHA currently provides the applicant [requesting the emergency exemption] 10 calendar days advance notice before posting the request for emergency exemption for public comment.

Propose changing from 10 calendar days to 3 business days.

409-070-0025 Acquisition of Control; Presumptions and Disclaimers

409-070-0030 Requirement to File a Notice of Material Change Transaction

It is a known issue that the current HCMO fee schedule, effective January 2023, is insufficient to cover costs, as directed by the legislature.

Through the 2025 rulemaking process, OHA will be proposing a revised HCMO fee schedule.

The proposed revisions will be included in the second draft redline rules for discussion at the November 20th RAC meeting.

State not recovering costs for new Oregon merger reviews

Fees paid by companies fall far short of covering expenses of program set up to protect patients, consumers

409-070-0035 Material Change Transaction Involving a Domestic Health Insurer

409-070-0040 Material Change Transaction Involving a Charitable Organization or Hospital

409-070-0042 Optional Application for Determination of Covered Transaction Status

OHA is proposing rule changes to align with current practice around publishing the determination letter.

- If the entity consents, or if the transaction is publicly known (including HCMO beginning a review of the transaction), HCMO will post the determination letter within 1 business day.
- If the entity does not consent or if the transaction is not publicly known, HCMO will post the determination no less than 6 months after the transaction closes (if it does).

409-070-0045 Form and Contents of Notice of Material Change Transaction

OHA is proposing rule changes to align with current practice:

 The entities must provide complete and final definitive agreements no later than 15 days after the preliminary review period begins. If the entities cannot provide these agreements, the preliminary review period will be tolled.

409-070-0050 Retention of Outside Advisors

OHA is proposing:

- Requiring OHA and DOJ must require that outside advisors are not subject to any conflicts of interest and will protect confidential information.
- Adding 'related costs for document management software' to the list of reimbursable costs.
- Adding clarification that failure to pay within 30 days of receiving an invoice may result in additional actions under Oregon statute for delinquent accounts.

409-070-0055 Preliminary 30-Day Review of a Notice of Material Change Transaction

409-070-0060 Comprehensive Review of a Notice of a Material Change Transaction

OHA is proposing adding clarification that a transaction may be disapproved or suspended if the parties do not agree to an extension of time necessary to accomplish a Tribal consultation.

409-070-0062 Community Review Board

OHA is proposing:

- Adding clarification that a CRB must consist of <u>at least 3</u> <u>individuals</u>.
- Clarifying that no more than one third of CRB members may be representatives of <u>institutional or</u> corporate providers.
- Adding that OHA may toll the comprehensive review period if the entities do not respond within a required timeframe to a CRB request for information.

409-070-0065 Conditional Approval; Suspension of a Proposed Material Change Transaction

OHA is proposing adding that it may impose civil penalties against an entity for each failure to comply with a condition that is not resolved within 30 calendar days of written notification.

409-070-0067 Violations and Civil Penalties

OHA is proposing adding a new section to the rules, specifying violations and civil penalties.

- Up to \$10,000 per offense when an entity fails to timely submit a notice of material change transaction
- Up to \$5,000 per offense when an entity fails to submit a required data element ... related to a condition

- Up to \$10,000 per offense when an entity fails to timely respond to a clarifying question or information request from OHA.
- Up to \$10,000 per offense when an entity fails to provide requested documentation.
- Up to \$10,000 per offense when an entity fails to comply with a condition as specified in the Order.

409-070-0070 Confidentiality; Permitted Disclosures

OHA is proposing rule changes to align with current practice:

- OHA will publish the redaction logs.
- OHA will, in collaboration with DOJ, review all claims of confidentiality. OHA / DOJ may require additional information from an entity to justify their claims of confidentiality. Applicant must respond to inquiries and requests for additional information.
- Failure of an applicant to adequately justify grounds for confidentiality and to respond to OHA/DOJ may result in OHA not accepting confidentiality claims.
 - If this happens, OHA will notify the entity 2 business days in advance of public release.

409-070-0075 Contested Case Hearings

OHA is proposing adding language to describe how the Contested Case Hearings (CCH) process works for civil penalties (section 409-070-0067).

- Entities have 15 calendar days to request a CCH
- If entities do not request a hearing within this time period, OHA will issue an Order
- If the Order is not appealed, or appealed and sustained, the civil penalty is payable within 10 calendar days

409-070-0080 Compliance with Conditions; Information Requests

Housekeeping change: remove "Information Requests" from this section title. See section 409-070-0085 Information Requests.

409-070-0082 Follow-up Analyses After the Material Change Transaction

No proposed changes.

409-070-0085 Information Requests

OHA is proposing clarifying that entities must respond to requests for additional information within the timeframe outlined by OHA.


