## RESTATED ARTICLES OF ORGANIZATION OF ALEXANDER INFUSION, LLC

Under Section 214 of the Limited Liability Company Law of the State of New York

<u>FIRST</u>: The name of the company is "Alexander Infusion, LLC" (the "<u>Company</u>"), a limited liability company organized on July 21, 1997 and existing under the Limited Liability Company Law of the State of New York, as amended (the "NY LLCL").

<u>SECOND</u>: The date of filing of the initial articles of organization of the Company (the "Articles of Organization") is July 21, 1997.

THIRD: The text of the Articles of Organization is hereby amended to effect the following amendments (i) broadening the purpose of the Company, (ii) changing the county within the State of New York in which the principal office of the Company is located, (iii) changing the name and address of the registered agent of the Company for service of process on the Company, (iv) amending the Members of the Company, (v) deleting in its entirety Article Fifth of the Articles of Organization regarding dissolution of the Company, (vi) deleting in its entirety Article Eighth of the Articles of Organization regarding the personal liability of a Manager to the Company or its Members, (vii) adding a new Article Seventh providing that to the fullest extent permitted by the NY LLCL no Member of the Company shall be personally liable, (viii) adding a new Article Ninth specifying the requirements to amend, alter or repeal the provisions of, and add or insert provisions to, the Articles of Organization, and (ix) renumbering the Fourth through Ninth paragraphs of the Articles of Organization. The Articles of Organization are hereby restated as amended to be read as follows with renumbering of the remaining articles:

<u>FIRST</u>: The name of the Company is Alexander Infusion, LLC.

SECOND: The purposes of the Company shall comprise: (i) engaging in any lawful act or activity, for which limited liability companies may be formed under the NY LLCL; and (ii) all activities related or incidental to any of the foregoing. The Company shall have all the powers necessary or convenient to carry out the purposes for which it is organized, including the powers granted by the NY LLCL.

THIRD: The county within the State of New York in which the principal office of the Company is to be located is Nassau County.

<u>FOURTH</u>: The Secretary of State of the State of New York is designated as agent of the Company upon whom process against it may be served. The post office address within or without the State of New York to which the Secretary of State of the State of New York shall mail a copy of any process against the Company served upon him or her is 75 Nassau Terminal Road, New Hyde Park, New York 11040.

<u>FIFTH</u>: The name and address of the registered agent of the Company for service of process on the Company in the State of New York is Corporation Service Company, 80 State Street, Albany, New York 12207-2543. Such registered agent is to be the agent of the Company upon whom process against it may be served.

SIXTH: The Company is to be managed by 1 or more Members of the Company.

<u>SEVENTH</u>: No Member of the Company shall have any personal liability to the fullest extent permitted by the NY LLCL, as the same may be amended and supplemented from time to time. Any repeal or modification of this <u>Article Seventh</u> shall not adversely affect any right or protection of a Member of the Company existing immediately prior to such repeal or modification.

<u>EIGHTH</u>: The Company shall have the power to indemnify, to the fullest extent permitted by the NY LLCL, as amended and supplemented from time to time, all persons whom it is permitted to indemnify pursuant thereto.

<u>NINTH</u>: From time to time, any of the provisions of this Restated Articles of Organization may be amended, altered or repealed, and other provisions authorized by the laws of the State of New York at the time in force may be added or inserted in the manner and at the time prescribed by said laws, and all rights at any time conferred upon the Members of the Company by this Restated Articles of Organization are granted subject to the provisions of this Article Ninth.

TENTH: The: Company and each Member of the Company has a duty to report to the New York State Department of Health any proposed changes in the Membership of the Company. Prior written approval of the Public Health Council is necessary for such change in Membership before any such change is made, except that a change in Membership resulting from an emergency caused by the severe illness, incompetency or death of a Member of the Company shall require immediate notification to the New York State Department of Health of such fact, and application shall be made for the approval by the Public Health Council of such change in Membership within thirty (30) days of the commencement of such emergency. The Members shall be individually and severally liable for failure to make the aforementioned reports and/or applications.
