I've garnered a nuanced understanding of the intricate healthcare challenges Oregon communities face. Additionally, as a practitioner in California, I have been able to closely observe SCAN's operations and can attest to their reputation as a highly regarded insurer for seniors as well as an active community partner in addressing broader healthcare needs is well-earned.
