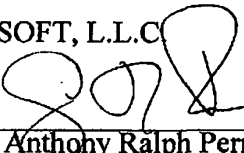

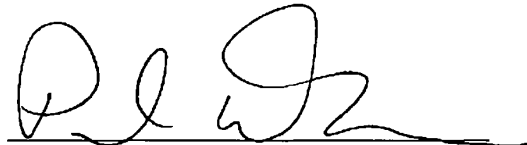

INVASOFT, LLC, (the "Company") a limited liability company organized and existing under and by virtue of the provisions of the Arizona Revised Statutes (the "Code"), does hereby certify:

- A. The present name of the Company is InvaSoft, LLC.
- B. The original Articles of Organization of the Company were filed with the Arizona Corporation Commission on February 11, 2005, and amended by filing certain Articles of Amendment with the Arizona Corporation Commission on November 23, 2010, and further amended by filing certain Articles of Amendment with the Arizona Corporation Commission on August 14, 2013, and further amended by filing certain Articles of Amendment with the Arizona Corporation Commission on September 18, 2013, and further amended by filing certain Articles of Amendment with the Arizona Corporation Commission on September 21, 2022.

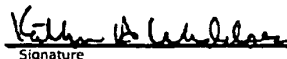
