**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
STATESERV MEDICAL OF HOUSTON, LLC**

(Pursuant to § 29-3202 of the Arizona Revised Statutes)

StateServ Medical of Houston, LLC, (the "Company") a limited liability company organized and existing under and by virtue of the provisions of the Arizona Revised Statutes (the "Code"), does hereby certify:

A. The present name of the Limited Liability Company is StateServ Medical of Houston, LLC.

B. The original Articles of Organization of the Company was filed with the Secretary of State of Arizona on January 18, 2022.

C. This Amended and Restated Articles of Organization, which amends and restates the Company's Articles of Organization in its entirety, has been duly adopted pursuant to the provisions of § 29-3202 of the Code.

D. This Amended and Restated Articles of Organization restates and integrates and further amends the Articles of Organization as herein set forth in full:

1. Name. The name of the Company is StateServ Medical of Houston, LLC.

2. Registered Office. The Mailing address of the Company's registered agent and office in the State of Arizona is 3800 North Central Avenue, Suite 460, Maricopa County, Phoenix, Arizona 85012. The name of the registered agent at such address is C T Corporation System.

3. Management. The Company will be manager-managed. Managers may be appointed from time to time by the Company's members in accordance with the terms of the Company's limited liability company operating agreement then in-effect. 5. Duration. The duration of the Company is perpetual.
