## Dear Community Stakeholders,

The Oregon Health Authority, Office of Health Analytics, is preparing to engage in rulemaking for the community benefit reporting program, in support of the requirements of HB 3076 (2019). OHA is amending Oregon Administrative Rule chapter 409-023 to update community benefit reporting requirements, to add requirements for reporting affiliated clinics, to establish a minimum community benefit spending floor program, and to solicit feedback for a proposed methodology for calculating minimum community benefit spending floors for hospitals or health systems in Oregon. The Oregon Revised Statutes (ORS) that define the hospital community benefit reporting program are ORS 442.601 through 442.630.

OHA will convene a Rules Advisory Committee (RAC) to provide feedback on the proposed rule changes from content experts and those who are likely to be affected by the rule. **All RAC meetings will be held virtually using the Zoom platform.** Due to the scope of proposed rule changes, <u>OHA is scheduling three meetings</u>. The anticipated meeting topics are:
