
#### **Report Timing/ Access**

Report	What is the report used for?	When does data populate?	What does a CCO user see?	What does a clinic user see?
CCO Operational Report	Track progress on data submission/ data coming in as expected	As data is submitted	All data for the CCO	Organization's data row(s), based on TIN
CCO Organizational Report	Monitor performance on measures	As data is submitted	All data for the CCO	Organization's data row(s), based on TIN



#### **Download Options**

- Image Snapshot of what is currently displayed
- Data Downloadable file to open in spreadsheet;
   can select extra data points not seen on screen.



- Summary Provides rows of data that make up current report
- Full data set Provides option to add or remove additional columns used in report that are not seen on the screen
- Crosstab Downloadable file of the data currently displayed on screen; like the image option but can be opened in spreadsheet.
- PDF More flexible than Image because user can choose paper size and orientation for larger reports; items requiring horizontal scroll bar are wrapped down to a new page as needed.






**Draft Architectural Roadmap** 





