

2025 PCPCH Recognition Criteria Technical Assistance Webinars

Beginning January 1, 2025, primary care practice applying for Patient-Centered Primary Care Home (PCPCH) recognition from the Oregon Health Authority (OHA) will be required to meet revised recognition criteria. The PCPCH program is hosting a webinar series to help practices prepare to implement the 2025 PCPCH recognition criteria. At each webinar PCPCH program staff will review a specific standard's technical specifications and answer any questions practices may have about the standard.
