Apply by May 18th to become a PCPCH Clinical Transformation Consultant



The Oregon Health Authority (OHA) [Patient-Centered Primary Care Home](#) (PCPCH) program is still accepting applications for Clinical Transformation Consultants (CTCs) until Wednesday, May 18th at 3:00 PM.

CTCs are primary care providers who support and foster innovation in primary care practices across Oregon. CTCs partner with OHA PCPCH program staff to conduct site visits to PCPCHs and provide peer-to-peer consultation to PCPCH providers. This opportunity is open to primary care providers with the following licenses: MD, DO, PA, NP, ARNP. This is a part-time contracted position with most CTCs conducting one site visit a month. OHA expects to award up to six contracts in this solicitation.

Free webinar: increasing access to medication abortion in primary care settings (with CME & CNE)

Thursday, May 26th at 9:00 AM

The Primary Care Development Corporation (PCDC) and the Reproductive Health Access Project (RHAP) are hosting a virtual clinical workshop on providing medication abortion in primary care settings. This workshop was developed for clinicians and other interested health center staff and/or managers who would like to learn more about medication abortion and how to incorporate medication abortion care into their practice.

This workshop will be led by two family physicians who provide medication abortion at a federally qualified health center and will include both a didactic presentation and participatory case study exploration. The objectives are:

- To describe the steps to provide medication abortion care with mifepristone and misoprostol
- To explain the tenets of non-judgmental abortion options counseling
- To apply knowledge on medication abortion regimens to answer questions or provide follow-up care
- To access resources to solve administrative and logistical barriers to providing medication in primary care

OHA recruiting providers for culturally responsive immunization presenter training

The OHA Transformation Center is partnering with the Oregon Academy of Family Physicians, Boost Oregon, and Oregon Rural Practice-based Research Network (ORPRN) to bring culturally and linguistically robust education to rural communities and communities of color. They are seeking 20 clinicians who are passionate about vaccine education and serving their community to participate in this project. Boost Oregon will provide speaker training, culturally appropriate messaging, slide decks and supplemental materials about COVID-19 vaccination to participating providers. Providers chosen will then give up to three 1–2 hour presentations. Presentations will be held at community gatherings, such as church events, community events and online events.

- Application for CME credit has been filed with the American Academy of Family Physicians. Determination of credit is pending.
- Clinicians will receive a \$1,000 stipend for each presentation provided.

COVID-19 updates and resources

Oregon Electronic Vaccine Cards Now Available

Patients and providers can now receive a free electronic copy of the COVID-19 vaccinations they've received in Oregon. An electronic vaccine card contains the same information as your paper vaccine card, but as a QR (quick response) code on your smartphone. The data comes from Oregon's vaccination system. When you show someone your QR code, they can scan it. These voluntary electronic vaccine cards are available in 13 languages. They are not shared with other government agencies and do not include information such as address, phone number, social security number or immunization status.
