# REALD & SOGI requirements in TQS

# What gets counted, counts!

Who decides who counts? Data systems are not neutral, and data has historically been used to colonize

impacts communities by making "them invisible when policies are made, resources are allocated, and programs are designed and implemented" (Hasnain-Wynia, et al 2012)



# **REALD & SOGI requirements for TQS projects**

TQS projects that use member-level data must:

- ✓ Analyze all aspects of REALD & GI
- ✓ Identify any disparities
- ✓ Include project activities to address those disparities
- ✓ Include policy or programmatic recommendations to address any inequities identified
- ✓ Disaggregate member-level targets and benchmarks by REALD & GI categories
- ✓ Describe a plan for using sexual orientation data when it's available




### Analyze all aspects of REALD & GI

(Project context)

- ✓ Analyze race, ethnicity, language, disability and gender identity data.
  - Every element
  - At most granular level possible
  - Consider intersectional analysis to better uncover disparities
- ✓ Identify disparities or gaps
- ✓ Include at least a statement that all elements were analyzed, and then more detail (data or findings) on the disparities identified and prioritized for intervention.
  - Describe what you looked at, what you found, where you decided to focus for intervention, and why.
  - Small populations okay for internal analysis and interventions; use discretion in reporting

# Common REALD & SOGI Topics for 2024 TQS

# **Small data populations**



For confidentiality reporting requirements, please follow HIPAA and guidance from your CCO leadership.

- What does a CCO do if there are smaller populations in your data?
- What does a CCO do if there are smaller populations in your community?

Rather, OHA challenges CCOs to...

- Evaluate equity impacts and suppression on erasing smaller communities.
- Consider what is known/unknown about the population.
- Address underlying needs, even when suppression is required.



# Include project activities to address any disparities identified

- ✓ If project is in early stages, identify how the project will identify, measure, implement interventions to address disparities and inequities.
- ✓ If disparities were identified for the project population, include activities and monitoring measures to address those disparities.
  - What will you do to make access, services, health outcomes, etc. more equitable for the populations with identified disparities?
- ✓ Disaggregate targets and benchmarks by granular REALD & GI categories
  - How will you know you're making progress?



# Include policy or programmatic recommendations to address any inequities identified

- ✓ CCOs can report their programmatic recommendations in the project description and/or through the project activities
  - Clear linkages of the activity to the inequities can be described in the brief narrative description if not easily identifiable by the activity itself.
  - Subsequent monitoring measure(s) inclusive of REALD and/or GI data tracking.
- ✓ For newer or startup projects, CCOs may submit a policy to support efforts to address identified inequities.
- ✓ Long-term projects may submit a policy or describe future policy changes to support efforts to address identified inequities.

# Describe a plan for using sexual orientation data

#### **Expectation of CCO's plan:**

- ✓ The plan may include but isn't limited to:
  - How the CCO can identify the population
  - How the CCO plans to use the data
  - What health disparities the CCOs want to address
  - A plan for engagement, research and analysis into sexual orientation disparities
  - How the CCO will protect this data from misuse

### TQS w/REALD & GI population scenario

TQS component: Oral Health Integration

Population: Adults with diabetes needing oral health

evaluation

**REALD & GI analysis results:** Disproportionate utilization of those with diabetes who had an oral health evaluation for male identifying Hispanic, white race than non-Hispanic white male.

**Project/intervention**: Implement a project that is inclusive of REALD & GI considerations. Work with local public health authority, community-based organization, oral health providers, patient centered primary care home (PCPCH) clinic sites, and community partnerships.

#### **Monitoring measure:**

8. Diabetes case management culturally responsive and outreach plans by REALD & SOGI.

#### **Monitoring measure:**

9. # of adults with diabetes reported by REALD & GI who were seen by PCPCH tier 3 (and above) clinic who receive oral health evaluations.


