





# Data dictionary

The data sources for the Social Complexity indicators used by the DHS-OHA Health Complexity project are included below. Where applicable, caveats to the data sourcing are included in the commentary. For DHS data, the source systems provided their data to DHS-Integrated Client Services (ICS), who matched clients across multiple programs. The program caseload categories of the source systems are included for all DHS-ICS data used.

Placements prior to 2011 were imported from the legacy FACES system and were imported by DHS/OHA staff manually in 2011 and may not include all Foster Care placements prior to 2011. This means it is likely we are not capturing all children who interacted with the foster care system prior to 2011.

### Foster Care

DHS-ICS data from 2000 – 2022. Data after August 2011 is from the OR-KIDS Child Welfare Information System implemented by DHS. The data prior to 2011 may not include all Foster Care placements as the data were manually imported from a legacy system. All included caseload categories are listed below. This includes Foster Care placements, where a child is removed from the home and placed in the care of a relative or a contracted provider, as well as other placements and interactions. While differing levels of care are included, individuals placed in certain settings may not have been placed for similar reasons as their peers and inferences about the child's social risk based on the level of foster care placement cannot be made using these data. All interactions were treated equally.

#### Parent Death

The data provided for this category are provided by DHS-ICS and sourced from OHA Vital Statistics. This data is limited to biological parents as identified on the child's birth certificate, and only for parents who died in Oregon or had their death reported in Oregon. The data in ICS dates to 1989 for birth and death certificates and is limited in this study to the life of the child plus one calendar year.

#### Parental Incarceration

DHS-ICS data sourced from Oregon DOC and includes all individuals incarcerated or supervised by the Oregon Department of Corrections. This is limited to state-level felonies only, and for only individuals incarcerated or supervised by DOC.

#### Mental Health

Data were provided by OHA to DHS-ICS from 2000-2022. Data from prior to December 31, 2014 were from the Client Process Monitoring System (CPMS) and data after December 31, 2014 were from the Measures and Outcomes Tracking System (MOTS).

## Child Abuse and Neglect

Data was sourced from ICD-9 and ICD-10 diagnosis codes for children on the dataset and were provided by Oregon Health Authority. These codes include T74, T76, Z62, and the 995.5X ICD-9 codes.

# Potential Language Barrier

The data source for this potential risk factor comes from OHA Medicaid data sources and reflects the individuals' primary language preference on file with OHA. These data were obtained from Medicaid enrollment for the client and reflect the most recent data available in 2022. OHA does not keep historical data on primary language preferences.

## Parent Disability

These data were obtained by OHA from DHS source systems. This potential risk factor is present for children whose biological parents were listed as having a disability during their Medicaid enrollment. The data reflect the most recent Medicaid enrollment data available in 2022. Disability determination was made by the DHS Aging & People with Disabilities program using their established Service Priority Levels (SPL)<sup>8</sup>.
