## **CCBF 2025 Grant Program Overview**



#### What are Community Capacity Building Funds?



HRSN Community Capacity Building Funds (CCBF) are funds to support organizations (e.g., community-based organizations, social service agencies and others) to become <a href="https://example.com/HRSN service providers">HRSN CCBF funds are managed through coordinated care organizations (CCOs).</a>




These funds support organizations that intend to become HRSN service providers to develop what they need to participate in the Medicaid delivery system and deliver HRSN services to eligible OHP members. Funds are also available to entities who will support the provision of, but not directly provide, HRSN services (e.g., 'hub' or 'convener' entities).



CCOs administer the HRSN CCBF Grant Program—including by reviewing applications and awarding funding. **Applications can be submitted between April – May 30, 2025.** More information is available on <u>OHA's CCBF web page.</u>

#### **Community Capacity Building Funds:** Allowable Uses\*







Workforce Development (e.g., staff salary up to 18 months and trainings)



Outreach and Education (e.g., launching a new learning collaborative)

#### **Eligible Entities for Community Capacity Building Funds**

## The following entities are eligible to apply for and receive HRSN CCBF (examples are not exhaustive)\*:

- Community-based organizations (e.g., housing agencies and food and nutrition providers)
- Organizations that provide (or intend to provide) or coordinate HRSN benefits (e.g., case management providers or local governmental agencies)
- Organizations that will support the development of the HRSN network (e.g., an entity that provides administrative, billing, training supports or other supports)

#### 2025 HRSN CCBF Allocation Amounts by CCO

2025 HRSN CCBF CCO allocations are based on an equal base amount and member enrollment forecasts to ensure all CCOs have enough capital to make meaningful investments in HRSN capacity




#### Ready to Enroll as an HRSN service provider?

- Enroll as an HRSN provider with a CCO, Open Card, or both:
  - **CCO**: You can <u>contact the CCO(s)</u> in your area to learn how to apply to become a provider for each CCO.

#### **HRSN Webpage Update**

- To align with the waiver, there have been updates to the main HRSN web page.
- Housing benefits include home changes for health during extreme weather.
- Eligibility and services are not changing.



#### **HRSN Webpage Update: Housing**

Updates to the HRSN housing web page

 This link will take you to the web page for air conditioners, air filters and other home changes for health devices



#### What Are HRSN Housing Benefits?

- Help paying rent for up to six months. This includes late payments.
- Help paying for utilities like gas, electric and water. This includes setup and late payments.
- · Up to six months of storage fees.
- Tenancy support help understanding your lease, speaking with your landlord and referrals to other services.
- Home changes for safety pest control, heavy duty cleaning, and installation of ramps, grab bars, and drawer pulls.
- Home changes for health during extreme weather air conditioners, heaters, air filters, mini
  fridges and portable power supplies.

#### Where we are

Health-Related Social Needs (HRSN) services available now

#### March 2024

Home changes for health, such as air conditioners, air filters, and more

Outreach & engagement services

#### November 2024

Housing Benefits: rental assistance, home changes for safety, and tenancy services

Expanded outreach & engagement services

#### January 2025

Nutrition Benefits: nutrition education and medically tailored meals

Young adults with special healthcare needs (YSHCN) eligible for HRSN

#### 2026-2027:

Seeking to launch more benefits and make programmatic improvements (e.g., Fruit and Vegetable benefit). Currently evaluating programs and considering updates and timelines. More details to come.
