### **Overview**

The SHARE Initiative (Supporting Health for All through Reinvestment) was created through Enrolled Oregon House Bill 4018 (2018) and requires CCOs to invest a portion of profits back into communities to address health inequities and the social determinants of health and equity (SDOH-E). For details, see OHA's <u>SHARE</u> <u>Initiative guidance document</u>. SHARE Initiative guidance is posted to the <u>SHARE Initiative webpage</u>.

In accordance with the requirements stated in <u>ORS 414.572(1)(b)(C)</u> and <u>OAR 410-141-3735</u>, CCOs must designate a portion of annual net income or reserves that exceed the financial requirements for SHARE Initiative spending. Starting in 2023, CCOs are subject to a+ formula that determines their required minimum SHARE obligation. CCOs will follow the instructions in the <u>Exhibit L6.7</u> financial reporting template to apply this formula to their 2022 financials and report their 2023 SHARE designation.

According to contract requirements, a CCO's annual SHARE Initiative designation must be spent down within three years of OHA's approval of the same year's SHARE Initiative spending plan; a one-year extension may be requested (four years total).

As described in OHA's SHARE Initiative guidance document, SHARE Initiative spending must meet the following four requirements:

- 1. Spending must fall within SDOH-E domains and include spending toward a statewide housing priority;
- 2. Spending priorities must align with community priorities from community health improvement plans;
- 3. A portion of funds must go to SDOH-E partners; and
- 4. CCOs must designate a role for the community advisory council(s) related to its SHARE Initiative funds.

It is important to note that SHARE Initiative reinvestments must go toward upstream, non-health care factors that impact health (for example, housing, food, transportation, educational attainment or civic engagement).

By December 31 of each contract year, the CCO shall submit a SHARE Initiative Spending Plan to OHA for review and approval. The spending plan will identify how the CCO intends to direct its SDOH-E spending based on net income or reserves from the prior year for the SHARE Initiative. This annual SHARE Initiative spending plan will capture from CCOs how they are meeting these contractual requirements.

EOCCO's SHARE Initiative spending supports projects that address social determinants of health and equity (SDOH-E) while improving housing services for EOCCO members. The <u>EOCCO Community</u> <u>Health Improvement Plan</u> identifies matters such as housing, early childhood, food insecurity, and behavioral health integration as priority areas within the plan. The SHARE projects that were selected for 2023 align with the objectives explicitly listed in the CHP and will help advance efforts by:

• Normalizing the need to seek parenting support in order to develop stronger parent-child

relationships, with a focus on stabilizing children in foster care placement.

- Helping create, develop, and implement collaborative partnerships that promote mental health in the community.
- Reducing the prevalence of food insecurity and hunger through safe, accessible, and community driven options.
- Expand the knowledge of the Community Advisory Council and residents local to the CCO's region in order to support community housing planning and development to provide safe, affordable housing within the eastern Oregon service area.

Additionally, each SDOH-E partner who submitted a SHARE project for consideration was asked how their project supports EOCCO's Regional Community Health Plan. The projects selected for the 2023 SHARE Initiative demonstrated strong alignment to the CHP priority areas. For more information on each partner's response see the partner agreements attached.

4. Describe how your SHARE Initiative spending addresses the statewide priority of housing-related services and supports, including supported housing.

EOCCO has decided to support organizations throughout Eastern Oregon whose services aim to increase supportive housing through the development and enhancement of affordable housing and housing-related services. By contributing funds to community-level projects, EOCCO aims to support underserved communities that typically face additional barriers. EOCCO would like to highlight four of our projects that address housing as a statewide priority. This includes:

- Housing weatherization, case management and wraparound services for high-risk clients provided by the Mid-Columbia Community Action Council (MCCAC). This project will also support rehousing services such as assistance with security deposits and limited duration rent, landlord incentives, outreach supplies, and client incidentals.
- Implementation of an Adult Foster Home in Boardman, Oregon led by the Morrow County Health District.
- Expansion of services provided by the Social Resource Navigator to guests at the Union County Warming Station.
- Supporting the expansion of Lifeways Malheur Transitional Housing by fitting two additional units to serve individuals who are homeless or at risk of homelessness.



# 6. Describe how each of the SDOH-E partners identified above were selected for SHARE Initiative project(s) or initiative(s).

A rigorous process was implemented to select each of our SDOH-E partners. In February of 2023, EOCCO put out a request for applications to partners pursuing projects addressing SDOH-E services in Eastern Oregon. The program was promoted through all twelve of EOCCO's Local Community Health Partnerships (LCHP), in addition to email distribution lists and the EOCCO newsletter. Four organized technical assistance sessions were held by the Oregon Rural Practice-based Research Network (ORPRN) during the application period, with ad-hoc consultations available to partners as needed. The goal of these sessions was to help applicants understand the SHARE program and ensure they were aligning their projects with existing priorities.

Interested SDOH-E partners were asked to submit their application to the LCHP in the county where their organization is located. Once the application window had closed, members of the LCHP then scored applications using a standardized scoring tool that rated each application for completeness, feasibility, and alignment with SHARE program requirements (see *Attachment B. 2023 EOCCO SHARE-LCHP RFA Scoring Guide Final* for more information). LCHPs passed along the scored applications and their recommendations for funding to ORPRN who enlisted a team of reviewers to evaluate the applications a second time before submitting the portfolio to the Community Advisory Council (CAC).

Each project was reviewed by a group of volunteer CAC members to identify the projects that best aligned with the SHARE program requirements. Recommendations were presented to the full EOCCO CAC during the May 2023 committee meeting. A formal vote was held to determine which SDOH-E partners would receive funding. Applications were then presented to the EOCCO Board of Directors in June 2023, who made the final approval based on the recommendations brought forward by the CAC.

#### Community advisory council (CAC) role

The CAC had a robust role in determining the SHARE spending decisions. As noted in question 6, there were several steps taken before consulting the CAC on the final projects to be selected. EOCCO's Community Health Development Team (Field Team) took the initiative in coordinating this review.

Once the SHARE application cycle was closed, each of the 12 LCHPs reviewed the applications and scored them using a standardized scoring rubric. After the applications were scored, the LCHPs then

ranked each proposal based on the community needs/priorities. From there, the CAC received all the applications, along with the scoring rubrics from each LCHP. The CAC created a sub-committee which reviewed each application, along with the feedback from each LCHP. To evaluate and review all applications, the CAC sub-committee established three dates to review them. The first day consisted of an orientation to prepare the group to review the applications and discuss the process. The two other dates consisted of reviewing and discussing each project in detail. After a long discussion, the CAC sub-committee narrowed it down and selected 16 out of the 32 applications for funding. Information was presented at the May CAC Meeting, where the CAC made a final vote.

## 2023 SHARE Funded Projects

#### **Baker Relief Nursery Inc.**

Project Title: Transportation for Rural Children and Families
County: Baker
SDOH-E Category(ies): Neighborhood and Built Environment, Economic Stability, Education, Social and Community Health.
Populations Served: Families who are experiencing multiple stressors that increase the likelihood of

child maltreatment and foster care placement. 95% of current children and families in the program are EOCCO members. Upon enrollment to the program, parents complete an application that includes insurance information.

Amount Funded: \$50,000

**Summary:** The Transportation for Rural Children & Families project would assist Baker Relief Nursery in providing door-to-door transportation for all enrolled children throughout Baker City, where the majority of the families we serve reside. Our plan is to purchase a childcare and ADA approved bus that will not only ensure that at-risk children are present in our therapeutic classroom each day, but would also be utilized to transport entire families to attend our family fun events that occur each month, or to provide transportation to a group of parents wanting to attend our weekly, evidenced based parent education courses. These opportunities support parent and child attachment and bond, the number one predictor of positive outcomes for children, as well as help families build a positive social network. We have found that even with gas vouchers, bus tickets, taxi purchases, there are still many families that are unable to get to our facility. Our plan is to implement transportation services by November 2023.

## Community Connection of Northeast Oregon, Inc.

**Project Title:** Community Connection Senior Nutrition Equipment Replacement **County:** Wallowa

**SDOH-E Category(ies):** Economic Stability, Neighborhood and Built Environment, Social and Community Health

**Populations Served:** According to Oregon Health Authority data, there are 2,797 Medicaid recipients in Wallowa County. Approximately 492 are over the age of 55 per the data. During the last fiscal year, over 9,900 meals were served to an average of 63 people each day at senior meal sites and delivered 8,528

meals through Meals on Wheels program. Approximately 17 of the 55 people meals were delivered to are Title XIX recipients.

Amount Funded: \$41,545

**Summary:** Congregate meals and Meals on Wheels are existing programs that Community Connection has been proud to provide for many years. Like so many important programs, we do our best to prepare quality meals in both of our senior centers; one in Enterprise and one in Wallowa. A third-party dietician approves all meals to meet USDA nutritional guidelines and the meals are very popular with many of the senior residents in each community. While we have been remarkably successful in managing our resources and always provided meals for those in need, we have come to a point where some of our equipment in the Enterprise center is need of repair or replacement. Most of our equipment dates to the opening of the center in 1996. Funding to replace this equipment will allow us to continue to serve 9,900 annual meals or 63 people each Monday, Wednesday, and Friday at our senior meal sites and deliver 8,528 meals annually to approximately 55 recipients through our Meals on Wheels program to support home-bound seniors.

## Condon Child Care, Inc.

Project Title: Condon Early Leaning Center Expansion

County: Gilliam

**SDOH-E Category(ies):** Neighborhood and Built Environment, Economic Stability, Education, Social and Community Health

**Populations Served:** This Condon Early Learning Center Expansion project will primarily benefit working families with children ages 0-5 in Condon. The chief goal of the project is to ensure that every family with young children – including EOCCO members – has access to high-quality, affordable Early Educa<sup>®</sup>On services if and/or when they need them. It is challenging to predict the number of EOCCO members who will ultimately benefit from the project as its impact will last for decades, and most children who will receive services because of the expansion have not been born yet. As part of the enrollment process, the Condon Early Learning Center collects health insurance and financial information to determine each family's eligibility for Early Head Start, Head Start, and other programs that are provided. Based on current enrollment data, nearly 50% of enrolled students (13 of 27 students) listed EOCCO as their health insurance provider. Although some families choose not to provide health insurance information, the enrollment data from those who do so will provide a reasonably accurate tool to track the number of EOCCO members who receive the services each school year moving forward. It is not expected to service OHA defined transition services with any of the above projected covered services.

**Summary:** Opened in 2018, the Condon Early Learning Center facility was built to meet the needs of the Condon community at the time with one Infant/Toddler Classroom (serving up to 8 children ages 0-3), and one Preschool Classroom (serving up to 20 children ages 3-5). In the years since, and particularly during the COVID-19 pandemic, demographics in Condon have shifted significantly. More families with young children are relocating or choosing to start their families here, and the Condon Early Learning Center now has a waitlist for its Infant/Toddler Room that is nearly double its capacity. To meet this increased demand and ensure there is an Early Education slot for every child in Gilliam County, ages 0-5, who needs one, Condon Child Care is proposing to expand its Condon Early Learning Center facility. The

expansion would result in three additional classrooms and would provide the following benefits to EOCCO members and the broader community:

- Eliminate current Early Education waitlists in Condon and help ensure EOCCO members have an Early Education slot available when they need one;
- Create up to 10 new direct jobs;
- Support retention/recruitment of up to 70 employees at local and regional employers by ensuring working families including EOCCO members with children ages 0-5 have access to Early Education services for their children.

## **Crossroads Ranch of Harney County**

Project Title: Crossroads Ranch of Harney County Activities For All County: Harney

**SDOH-E Category(ies):** Neighborhood and Built Environment, Social and Community Health **Populations Served:** The program currently assists 23 local individuals with approximately 85% being EOCCO members. Insurance enrollment is tracked through registration forms that include insurance information for use in case of any emergency. These forms will be used for anyone who participates in any of the established programs.

Amount Funded: \$84,400

**Summary:** Crossroads Ranch of Harney County is currently holding horse camps and lessons for anyone of any age who desires them and can afford to pay for them. Research and the experiences of our guests have shown that spending time with horses can help with mental and behavioral health. This part of our project, if we are funded, would enable us to provide these camps and lessons to those who don't have the ability to pay as well. We will be able to extend services from 23 children and adults now to 50+ children and adults. It would also allow us to secure horses and a pony for those who are smaller and for those who may be intimidated by a larger horse. We would also use the funding for winter facility fees, more helmets, hay and insurance, snacks, and crafts at camps and during our summer program.

#### **Fossil Community Food Pantry**

Project Title: Fossil Community Food Pantry Facility

County: Wheeler

**SDOH-E Category(ies):** Economic, Neighborhood and built environment, Social and community health. **Populations Served:** All 504 Medicaid recipients living within Wheeler County, over 1/3 of the total population, qualify to receive services provided by Fossil Community Food Pantry. This includes the 423 EOCCO members and 36 Open-Card members in Wheeler County as of March 15, 2023. The new facility will allow for more efficient/private intake and referral to other programs and services including the Oregon Health Plan.

#### Amount Funded: \$100,000

**Summary:** Wheeler County proposes to design and construct a safe, accessible, and appropriate facility for the Fossil Community Food Pantry (FCFP). The proposed facility will be located on County owned land adjacent to the location where FCFP clients currently receive services (Exhibit A). The new facility will include a distribution space which will create a shopping style experience, a commodity storage space with a loading dock for commodity deliveries, bathroom(s), and an office space to facilitate private client intake (Exhibit B). This application requests \$212,500.00 to bridge the projected funding

gap necessary to successfully deliver this project. Specifically, the requested funds will be used for: facility design including architectural and engineering services; permitting costs; site preparation; equipment for the new facility; and to cover some construction materials and labor costs. This is a project supported by Gov. Kotek's Regional Solutions Team to help develop robust local food systems within Wheeler County.

#### **Grant County Childcare Committee**

Project Title: Humbolt Childcare Center

#### County: Grant

**SDOH-E Category(ies):** Economic Stability, Education, Social and Community Health.

**Populations Served:** The target group of people who will benefit from this project are children ages 0-5 in Grant County and their families. It is anticipated that many of these families will have working parents who need a safe, consistent, reliable place for their children. It is expected that at least 50% of the children and families who will enroll at Humbolt Childcare Center will be EOCCO members, roughly 17 children and their families each year. To help facilitate EOCCO member enrollment, the childcare center will participate in the Employment-Related Day Care program (ERDC). The center also expects to offer Preschool Promise and Baby Promise.

Amount Funded: \$100,000

**Summary:** We are currently partnering with Grant School District #3 to create a childcare center for children 0-5 at Humbolt Elementary for the families of Grant County. The Humbolt Childcare Center currently has the capacity to serve up to 8 infants, 8 toddlers, and 18 preschoolers, depending on staffing levels. The full range of ages allows families to have access to consistent continuity of care from 6 weeks to 6th grade on the same campus. Grant School District has agreed to pay initial facility and staffing costs, while the GCCC is helping with facilitation and start-up funding. We are planning to open by September 2023, and have already begun the process of hiring staff. However, the classrooms we use this year will not sustain the program long-term, and we are already anticipating the need to move the program to a permanent home. The funds we are requesting will be used (with funds from other sources) to construct a permanent, childcare-specific building at Humbolt Elementary. The new building will not only be a permanent home, but it will also give us the opportunity to expand our numbers in the future to meet the high demand of the area.

#### **Grant County Education Service District**

## Project Title: Grant County School Backpack Program

County: Grant

**SDOH-E Category(ies):** Neighborhood and Built Environment, Education, Social and Community Health. **Populations Served:** 61% of students Grant County students, ages 6 – 18, are members of EOCCO. With input from the Grant County LCHP Coordinator and a screening process with Grant County schools, EOCCO membership has been identified and data has been established. As of 2021, there are over 1,900 EOCCO members in Grant County, and although this RFA targets youth ages 6 – 18, family members of students who are also EOCCO members will benefit from this project. **Amount Funded:** \$50,582 **Summary:** The Grant County School Backpack Program addresses childhood hunger and food insecurity in Grant County. Per the Eastern Oregon Regional Food Bank, the most recent data gathered indicates that Grant County is the number two county in the State of Oregon experiencing childhood hunger and food insecurity. As of February 2023, 8 of the 9 Grant County schools have over 50% of their student population participating in the school Free and Reduced Meal Program, with the exception of Seneca School, at 12 students enrolled, having less than 50% of their students participating in the Free and Reduced Meal Program. The Backpack Program will supply shelf-stable food items for eligible students for take home on non-school days. Total student enrollment in Grant County schools, less Pre-K, is 854 students, leaving 61% of students, ages 6 – 18, being members of EOCCO. Data, poverty, participation in the Free and Reduced Meal Program, and membership to the EOCCO indicates a strong need to address childhood hunger. A coalition comprised of several different businesses in Grant County supports the Backpack Program.

#### Harney County Senior and Community Services Center

**Project Title:** Food System Recovery in Oregon's Malheur and Harney Counties **County:** Harney

SDOH-E Category(ies): Economic Stability, Social and Community Health

**Populations Served**: Harney County also has an elevated Social Vulnerability Index risk score of 0.5436, (CDC, 2020), and a poverty rate of 16.2% compared to Oregon's 12.4% rate (United States Census Bureau, 2020). The food and social services supported by this project will serve very low income and senior populations in Harney County.

#### Amount Funded: \$42,247

**Summary:** This project addresses the USDA Track One priority of increasing access to nutrition assistance for a rural and frontier county where food distribution through the county's food pantry has virtually stopped due to COVID-19. Funding for this project will support the purchase and modest operational costs (fuel and insurance) for a new refrigerated food truck and a freezer for the food pantry. These will enable it to restart food sourcing and transportation, ultimately enabling the food pantry to once again provide food to the region, including to remote locations of the county.

#### Harney Partners for Kids and Families

Project Title: Allied Family Partnership Project

County: Harney

**SDOH-E Category(ies):** Housing Related Services and Support, Education, Social and Community Health. **Populations Served:** Youth with Special Health Care Needs ages 19-26 years old including complex needs including developmental delays, mental health conditions, substance use disorders, severe histories of trauma, and service needs surrounding their gender identity and/ or sexual orientation. Additionally, youth who are connected with child welfare services, including youth leaving foster care: This project specifically supports youth in child welfare custody who are in foster care. This project does not serve housing, food, or climate services.

Amount Funded: \$52,000

**Summary:** The Allied Family Partnership Project is designed to stabilize children in foster care placement by equipping resource families to meet their needs by supporting, training, and stabilizing resource families; providing intensive services to the child; and engaging kin and kith resources for the child to improve the child's relational health. Decreasing placement instability and serving children in their home communities are priories of this project. Four resource families certified by the Oregon Department of Human Services (ODHS) with experience will be identified to participate in this model. Two of these are continuing families from Harney County who started at the inception of this project in June of 2022 and 2 will be newly recruited families, one from Malheur County and one from Union County. Families will be either those with demonstrated histories of caring for children with mental health or behavioral challenges, or those with children currently in their care that are at risk for placement disruption. Families will engage with their local community mental health program and ODHS to support the child, and their family, and participate in designated training. Children served through the project will be from 6 eastern Oregon Counties (Malheur, Harney, Grant, Baker, Union, and Wallowa), and will receive Wraparound, IIBHT, and other intensive services considered appropriate, and will have access to 24 hr. 7 days a week crisis response.

#### Lake Health District

Project Title: Lakeview Community Arts Center

County: Lake

**SDOH-E Category(ies):** Social and Community Health, Neighborhood and Built Environment, Economic Stability

**Populations Served:** Since this service has never existed, it is difficult to estimate the number of EOCCO member participants. Members are often less engaged in community events, and we understand it will take time to earn their trust and help them feel comfortable attending events or workshops at the center. The goal to overcome this disengagement will be carried out by leveraging community partner support in ways that include but are not limited to: getting social service agencies to refer and encourage people to attend events and workshops, asking familiar community members in positions of trust to do the same whenever possible, and training staff to be sensitive to participants who may be challenged by being faced with past prejudices based on stigma or trauma. **Amount Funded:** \$49,017

**Summary:** Isolation has become the No. 1 determining factor for death among older adults. It negatively affects people of all ages, particularly those on the margins of society who are at increased risk for stigma, poor health choices, and suicide. Because of this, we will expand social and enrichment opportunities in our community by supporting efforts by the Lake County Senior Center, which now houses the youth arts center in the basement, to transition into a Community Arts Center with integrated programming space. Lakeview does not have a central all-ages gathering space for people to share enrichment activities outside schools or faith-based organizations. This excludes people who are not affiliated with schools or are uncomfortable in religious settings. A Community Arts Center aims to meet this need.

#### Lake County Food Share (LCFS)

Project Title: Warehouse Efficiencies Consultant Contract County: Lake **SDOH-E Category(ies):** Social and Community Health, Neighborhood and Built Environment, Economic Stability, Education

**Populations Served:** To participate in distributions, households must meet U.S. Department of Agriculture's Emergency Food Assistance Program or qualify for SNAP, TANF, Social Security, or the Low-Income Energy Assistance program (LIHEAP). Recipients will register with the Food Bank office in Klamath Falls, are assigned a number, and will check in each time they attend a distribution event at Food Share. Every participant gets 12 boxes per year, which may be filled at any time. When a person checks in at a distribution event, a volunteer marks this in the Klamath/Lake County Food Bank system and they will be asked whether they are an EOCCO member. **Amount Funded:** \$30,355

**Summary:** Lake County Food Share is a 501c(3) nonprofit that was established more than 20 years ago. The organization has always been operated by volunteers. Due to growth over the past several years, a 'consultant' is needed to evaluate the gaps and inefficiencies that exist in all areas of food pickup/stocking/system for inventories/weekly distribution/volunteer training/policies, community awareness, etc. The consultant will put in place all polices, process systems, training schedules and operating systems that will increase volunteer efficiencies, program efficiencies, policy and administrative efficiencies.

#### Lifeways, Inc.

Project Title: Lifeways Malheur Transitional Housing (LMTH) County: Malheur

**SDOH-E Category(ies):** Housing Related Services and Support, Neighborhood and Built Environment, Economic Stability, Education, Social and Community Health

**Populations Served**: The Lifeways Malheur Transitional Housing (LMTH) project will target single adults 18 and older of all gender types. All transitional housing residents will be Oregon Health Plan (OHP) EOCCO members who have been identified through existing Lifeways' service enrollment or through crisis services.

#### Amount Funded: \$150,000

**Summary:** A SHARE award of \$250,000 is requested to cover costs of fitting out two 576 square foot transitional {6-12 months} housing units w/plumbing, electrical, flooring, fixtures & furnishings within the built framework of the HB 5202 funded, Lifeways Malheur Transitional Housing (LMTH) facility with 8 completed 576 sq. ft. units. The addition of the 2 SHARE funded living spaces will create a total of 10 new Malheur County transitional housing units in Ontario, Oregon. Target population will be OHP adults who are homeless/at risk of homelessness; 65 or older w/Medi/Medi; and individuals transitioning from incarceration or state hospitals. An LMTH manager will monitor and assist with resident housing needs. Supportive services designed to facilitate stabilization and step up to permanent housing will be available through Lifeways (e.g., crisis, mental health/substance use therapy, employment, peer support, case management) and partnering agencies. Partnering agencies include Valley Family Health Care (medical, dental); Community in Action {housing placements} and Housing Authority for Malheur & Harney Counties (supplemental housing assistance). The LMTH project will coordinate with LCHP and seek to recruit other community partners or advocates for underserved populations to join or provide input on project services.

## **Oregon Regional Food Bank**

Project Title: Food System Recovery in Malheur County
County: Malheur
SDOH-E Category(ies): Economic Stability
Populations Served: Malheur County is vulnerable with a Social Vulnerability Index
risk score of 0.9965 indicating a high level of vulnerability. Malheur County reports a 21.1% poverty
rate, compared to Oregon's 12.4% rate (United States Census Bureau, 2020). Ultimately, this project will
serve many of the county's very low income and underserved residents..
Amount Funded: \$124,296

**Summary:** This project addresses the USDA Track One priority of increasing access to nutrition assistance for a rural and frontier county where food distribution through the county's food pantry has virtually stopped due to COVID-19. Funding for this project will support the purchase and modest operational costs (fuel and insurance) for a new mobile food pantry truck that includes a refrigeration unit for food pantry items. This will allow restarting of food sourcing in these remote regions in Eastern Oregon by providing transportation of food pantry items.

## Mid-Columbia Community Action Council (MCCAC)

**Project Title:** Housing Stabilization Supports for Sherman County Residents **County:** Sherman

**SDOH-E Category(ies):** Housing Related Services and Support, Economic Stability, Social and Community Health

**Populations Served:** The target group who will benefit from this project will be Sherman County residents who are currently experiencing or are at risk for houselessness. It is anticipated that between 5-15 EOCCO members will benefit from this project each year, for a total of 15-45 community members benefitting over the 3-year project timeline. Additionally, it is anticipated that the majority of individuals and families served by this project with be EOCCO members or will successfully be enrolled during participation in the project.

#### **Amount Funded:** \$100,456

**Summary:** Mid-Columbia Community Action Council (MCCAC) will ensure continued Housing Stabilization Supports for Sherman County Residents through EOCCO SHARE grant funds. Sherman County residents who are currently houseless or at immediate risk of houselessness will be provided housing case management with wraparound services, including assistance with security deposits and limited duration rent, landlord incentives, outreach supplies, and client incidentals. In addition to these wraparound rehousing services, a portion of EOCCO SHARE funds will be utilized to support staffing for this outreach and housing case management as well as a limited number of hotel vouchers for severe weather events and for clients awaiting housing placement. This project fits under the EOCCO Community Health Improvement Plan in the area of Economic Stability, and within that area, under the Priority of Housing.

## **Morrow County Health District**

**Project Title:** Implementation of an Adult Foster Home in Boardman, Oregon **County:** Morrow

**SDOH-E Category(ies):** Housing Related Services and Support, Social and Community Health **Populations Served:** All Morrow County EOCCO members, 3,749 individuals, could potentially benefit from this resource. Morrow County Health District (MCHD) will not cap the number of Medicaid patients admitted to the adult foster home. While the main intent of the adult foster home is to provide resources for elder care and those with physical disabilities, MCHD will also consider the needs of adults diagnosed with a qualifying mental illness, in partnership with Community Counseling Solutions. **Amount Funded:** \$25,000

**Summary:** Morrow County Health District proposes to implement an adult foster home (AFH) in Boardman, Oregon that will provide culturally appropriate housing, medical, and personal care to vulnerable populations. This project proposal encompasses the purchase or build of a suitable home and the AFH start-up expenses. Additional project activities will include the development of inclusive program policies to meet the diverse needs of the community.

## **Stepping Stones Alliance**

Project Title: Transportation County: Umatilla

SDOH-E Category(ies): Social and Community Health

**Population Served:** Homeless population within Umatilla and Morrow counties, including youth, people with special needs, older adults with Medicaid and Medicare health insurance, adults and youth released from incarceration, and adults leaving state hospital. Individuals self-report insurance status per choice.

#### Amount Funded: \$50,000

**Summary:** Stepping Stone Alliance (SSA) is in need of a passenger vehicle to shuttle guests to and from the site location, as well as accommodate guest appointment needs (medical, dental, classroom, etc), interviews, and access to community resources. Purchasing a vehicle will give SSA the self-sufficiency necessary to accommodate guest needs and improve guests' achievement of goals towards self-reliance.

#### **Union County Warming Station**

Project Title: Houseless to Housed Part 2: A Social Integration Project

County: Union

**SDOH-E Category(ies):** Housing Related Services and Support, Economic stability, Social and community health

**Populations Served**: It is projected that the project will serve 300 EOCCO members over the life of the project. Individuals are asked on guest intake forms if they have EOCCO as insurance, and if they do not, those individuals are connected with an OHP enrollment specialist to sign up. **Amount Funded**: \$75,000

**Summary:** The goal of our Social Integration project is to expand UCWS Social Resource Navigator (SRN) services and help guests engage in meaningful activities that aid in restoring them to full health and

community connection, integrating them back into the fabric of the community. These include standard services such as working with a SRN to connect EOCCO Members and EOCCO eligible members to traditional resources, as well as education support, employment search support, access to recreational and community services such as a garden onsite, and meaningful connection and relationship building with volunteers and nontraditional service providers such as spiritual health entities, artistic communities, and natural world exposure. Activities involved in this project will include further expanding our community network of volunteers, donors, and services providers, and securing long term funding from community partners to sustain staff without grant funding. This project is consistent with OHA SDOH-E guidelines by addressing inequities experienced by the houseless population, with a focus on integration into community life in a healthy manner. It also aligns with the EOCCO Regional CHIP priority areas of Housing, Food Insecurity, and Health Equity.

#### Winding Waters Medical Clinic

Project Title: Meals on the Move

County: Wallowa

SDOH-E Category(ies): Neighborhood and Built Environment

**Populations Served:** Between April 2022 and April 2023 – 219 EOCCO patients indicated via SDoH screenings at primary care visits that they were at risk for food shortage. January through March 2023: 40 Oregon Food Bank Food Box Sign in sheets were collected at the main clinic location from people picking up OHA-supplied temporary nutrition assistance and 79 individuals were reported. 69 of the 79 (87%) reported to be EOCCO members. The program is anticipated to benefit at least 10% of Wallowa County EOCCO members during the grant period and on an ongoing basis after the grant period has ended.

Amount Funded: \$35,000

**Summary:** Winding Waters sees persistent community need for sustainable, dependable delivery of fresh food from the Harvest Share Hub in La Grande, Oregon to Wallowa County. Winding Waters now has a clinic location in each of three Wallowa County communities (Wallowa, Enterprise, and Joseph) with reliable hours of operation and staff to provide access to food as well as other social/health/medical/dental services when people are accessing food supports. We are applying for funds to purchase reliable transportation, refrigerators, and food displays/baskets for each of our locations (Wallowa, Enterprise, and Joseph). These resources will empower Winding Waters to transport and stock food in our clinics, in partnership with the Harvest Share Hub, and with our own staff members reliably doing the work.
