Overview

The SHARE Initiative (Supporting Health for All through Reinvestment) was created through Oregon House Bill 4018 (2018). It requires coordinated care organizations (CCOs) to invest a portion of profits back into communities to address health inequities and the social determinants of health and equity (SDOH-E). For details, see OHA's SHARE Initiative guidance is posted to the SHARE Initiative webpage.

Per the requirements stated in ORS 414.572(1)(b)(C) and OAR 410-141-3735, CCOs must designate a portion of annual net income or reserves that exceed the financial requirements for SHARE Initiative spending. CCOs are subject to a formula that determines their required minimum SHARE obligation. CCOs will follow the instructions in the Exhibit L6.7 financial reporting template to apply this formula to their 2023 financials and report their 2024 SHARE designation.

The CCO contract requires a CCO's annual SHARE Initiative designation to be spent down within three years of OHA's approval of the same year's SHARE Initiative spending plan; a one-year extension may be requested (four years total).

SHARE Initiative spending must meet the following four requirements:

- 1. Spending must fall within SDOH-E domains and include spending toward a statewide housing priority;
- 2. Spending priorities must align with community priorities from community health improvement plans;
- 3. A portion of funds must go to SDOH-E partners; and
- 4. CCOs must designate a decision-making role for the community advisory council(s) related to its SHARE Initiative funds.

(See OHA's SHARE Initiative guidance document for more details.)

It is important to note that SHARE Initiative reinvestments must go toward upstream, non-health care factors that impact health (for example, housing, food, transportation, educational attainment or civic engagement).

By December 31 of each contract year, the CCO shall submit a SHARE Initiative Spending Plan to OHA for review and approval. The spending plan will identify how the CCO intends to direct its SDOH-E spending based on net income or reserves from the prior year for the SHARE Initiative. This annual SHARE Initiative spending plan will capture from CCOs how they are meeting these contractual requirements.

SHARE Initiative Reporting

 - Annual SHARE Detailed Spending in <u>Exhibit L</u>, <u>Report 6.71 to track spend-down to each SDOH-E</u> partner each year.
- B. By December 31, each CCO must complete the **Annual SHARE Initiative Spending Plan** described in this document for the *prior year's financials*.

The CCO's 2021 CHP includes seven priorities that consistently emerge as the most important to the Columbia Gorge communities. These include housing, food, sense of community, equitable access to health care services, children and youth, physical activity and the outdoors, and transportation.

The selected projects align directly with three of these priorities – housing, food, and transportation. The selected projects support other CHP priorities including, children and youth, sense of community, and equitable access to health care services. For instance, the Gorge Passes can create increased access to healthcare services by creating free transportation.

4. Briefly describe how your SHARE Initiative spending plan addresses the statewide priority of housing-related services and supports, including supported housing, and helps people find and maintain stable housing. In the description, please reference the specific housing projects using the

The SHARE Initiative spending directly addresses the statewide priority of housing-related services and supports through Project #1 that funds Mid-Columbia Community Action Council (MCCAC). MCCAC identified three distinct activities that, combined, will advance housing stabilization work in the Columbia Gorge region. The first activity is the creation of a flexible housing fund that will provide rental support for community members. This fund will expand existing funding and address funding gaps, for instance providing rental support in the case of month-to-month leases. The second activity supports a new Accounts Payable Specialist will be responsible for day-to-day processing of financial transactions for MCCAC, with key responsibilities specific to setting up and supporting landlords and utility providers in MCCAC's financial systems, processing rental assistance and utility payment invoices, and maintaining accurate records. (Of the total invoices received by MCCAC, rental and utility assistance invoices make up 75%.) Lastly, the third activity will support Office Coordinator position at The Gloria Center. This person is the initial point of contact for community members seeking services at The Gloria Center and will work with MCCAC's care coordination team to support meeting immediate client needs along with referrals to services by MCCAC and other Gloria Center partners. Additionally, the person in this position will undergo Community Health Worker training through the assistance of these funds.
