D. Describe how each of the SDOH-E partners identified above were selected for SHARE Initiative project(s) or initiative(s).

YCCO conducted a broad, open RFP sent widely to more than 400 partners with requests to share within their own partner networks. The RFP was posted on the YCCO website and on social media. YCCO also utilized the Service Integration Team networks and other funder partners to share with their networks. Once applications were received, they were reviewed through a detailed rubric, which included SHARE requirements, CHIP alignment, and standard YCCO funding criteria, like sustainability and reporting capacity.

An internal review committee utilized a detailed rubric based on SHARE requirements and CHIP alignment to score and select the top proposals. Scoring incorporated CAC feedback, funding received in the last 12 months, and fit with SHARE requirements. This process limited bias by restricting scoring to objective criteria and quantitative review. Final review incorporated discussion of alignment with CHIP and potential funding risks, including SHARE report rejection, relevant community needs, CHIP strategy alignment, geographic distribution, and project sustainability. Final recommendations were reviewed and approved by the CAC. Applicants were not contacted for clarification or more information after the application was submitted, except in the case of determining Medicaid exclusion, in order to not give any applicant an unfair advantage. The rubric includes the following elements. The first three elements were weighted as they indicate alignment with SHARE requirements. Scores followed a 3-point indicator: Does not meet, Meets, Exceeds (0, 10, 11 for weighted scores; 0, 1, 2 for all other scores).

- 1. Incorporates at least one CHIP focus (housing, nutrition, infants and youth, transportation, emergency preparedness, mental health and substance use, access to healthcare)
- 2. Addresses at least one SDOH-E: economic stability, built environment, education, social and community health, and/or housing
- 3. Applicant is non-clinical or offers non-clinical services and is considered an SDoH/CBO partner
- 4. Shows a realistic amount of FTE and partner support to implement project
- 5. Shows evidence that project can continue after funding has ended
- 6. Timeline is included with detailed project activities
- 7. Timeline is realistic and achievable in a one year grant cycle
- 8. Goals are clear and well defined
- 9. Lists at least three outcomes
- 10. Shows ability to measure progress, evaluate data, and determine success
- 11. Budget clearly describes all expenses directly applicable to the project
- 12. Evidence of in-kind contribution to support the project
- 13. Administrative cost request does not exceed 15%
- 14. Shows clear community need

- 15. Serves populations that experience disparities or marginalization
- 16. Incorporates feedback from target population

The final recommendations were presented to the YCCO Board of Directors, which has representation from across the YCCO service area. The Board reviewed the application and voted to approve.

The only exception to this open RFP process was the YCAP/City of McMinnville award. This award resulted from key conversations with members of YCCO's original Housing Leaders committee; in alignment with the process from the previous two SHARE awards. This initiative fits with YCCO's long term housing strategy and was proposed as a way to secure the funding to initiate a navigation center in McMinnville. This center meets a key need for paired sheltering, navigation, and social service delivery, but the need was presented before the SHARE RFP had been released and required a decision sooner than the SHARE cycle. Thus, YCCO brought together multiple partners and stakeholders to discuss the project, and the decision was brought to the Board of Directors for review and approval.

Community advisory council (CAC) role

Proposals were reviewed by the CAC on two separate occasions, and the group had the opportunity to inform the initial award selection criteria. Scores from the rubric were modulated according to the following criteria from CAC feedback and CHA/CHIP need considerations:

- 1. Location outside of McMinnville or Newberg
- 2. Program addresses teens
- 3. Program addresses disability or neurodivergence
- 4. Program addresses community education
- 5. Program addresses housing
- 6. Program has not received prior funding in this calendar year

The CAC was provided the opportunity to provide feedback and ask questions in its final review and approved the final recommendation on 10.17.23. The CAC will receive updates after the midpoint and final reports are received for SHARE projects, and will be invited to attend grantee site visits with SDoH partners when feasible, with SDoH partner consent.
