Subject: Request for Grant Applications (RFGA): Notice of Intent to Award for July 29, 2022 Cohort

The Oregon Health Authority (OHA) has reviewed and made award decisions for all applications submitted on or before July 29, 2022. <u>The awardee list on page 2</u> contains the full list of awardees. OHA continues to review applications and announce awards until funds are expended.

OHA plans to send a Conditional Award Letter to awardees. That letter will include:

- The amount of the award for a Real Property Development Project and for Start Up Costs,
- A description of the next steps, including executing a Grant Agreement and Declaration of Restrictive Covenants with OHA.

The Conditional Award Letter may also require the awardee to respond to questions or provide additional information as a condition of the award.

OHA congratulates the awardees and looks forward to partnering with you on upcoming property work.

What should you do?

Awardees: Do not use grant funds for any costs incurred prior to the date of the Conditional Award Letter, unless expressly authorized in the letter. If you have any such costs, please let us know right away.

To receive grant funding, please do the following if your organization hasn't completed them already:

- **Sign up for direct deposit.** To do this, submit a <u>completed Direct Deposit Authorization Form</u>. You are already registered, no further action is required.
- **Register with OregonBuys.** To do this, click on the blue "Register" button in the top right of the OregonBuys home page.

Other licensed residential treatment providers: OHA encourages you to submit applications by the next pull date if you applied but were not selected for this cohort's award list, or have not yet submitted an application. The next pull date is Oct. 31, 2022.

If you disagree with OHA's funding decision, please contact <u>Richard F. Malloy</u>. If this doesn't resolve the issue, you may request an appeal as described in <u>Section 11 of the RFGA</u>.

- The designee for receiving appeal requests is <u>Jesse Benet</u>. Submit requests by October 27, 2022.
- OHA will notify you in writing of the decision to approve or deny the appeal within 15 days of receiving the appeal.
