Subject: Division-approved Wraparound Foundational Training changes

The Oregon Health Authority (OHA) is implementing changes to the Division-approved Wraparound foundational training beginning in August 2025.

For Wraparound providers hired after August 1, 2025:

Wraparound Care Coordinators, Wraparound Family Partners, and Wraparound Youth Partners

- Introductory Wraparound Foundations Training: 4 modules facilitated by Portland State University, System of Care Institute (SOCI).
- Wraparound Role-specific training: 2 modules
 - Wraparound Care Coordinator specific training facilitated by SOCI
 - Wraparound Family Partner specific training facilitated by Oregon Family Support Network (OFSN)
 - Wraparound Youth Partner specific training facilitated by Youth Era

Providers may attend role specific trainings after completion of the Introductory Wraparound Foundations Training.

Completion of both the Introductory training and the provider's role specific training satisfies the minimum training requirements for the "Division-approved Wraparound"

foundational training" in the Oregon Administrative Rule (OAR) 309-019-0163 (4 e), (5 a), (6a). CEUs are anticipated for all trainings.

Providers are encouraged to attend all three role-specific trainings. Understanding the functions of all Wraparound core team members facilitates partnership, collaboration, and teaming in the Wraparound process. Registration for role-specific trainings will be prioritized for Wraparound providers of the same role type.

Wraparound Supervisors

- Introductory Wraparound Foundations Training: 4 modules facilitated by Portland State University, System of Care Institute (SOCI).
- Encouraged to attend all three additional role-specific trainings for WCC, Family Partner and Youth Partner within the initial year of hire.

Completion of the Introductory training and existing Wraparound Coaches and Supervisors training satisfies the minimum training requirements for the "Division-approved Wraparound foundational training" in the OAR 309-019-0163 (13 c). CEUs are anticipated for all trainings.

Peer Delivered Services Supervisors who supervise Wraparound Youth and Family Partners are encouraged to also attend the Introductory Wraparound Foundations Training above.

Current Wraparound providers

Current Wraparound providers who have completed the prior Division-approved Wraparound Foundational Training do not need to attend the new introductory or role-specific trainings. Current providers may choose; however, to enroll in the new role-specific trainings for all three role types. Registration will be prioritized for Wraparound providers entering the workforce after August 1, 2025. A certificate of completion from the prior Wraparound Foundational training *may* be requested prior to enrollment.
