Subject:	Fee-for-service Fidelity Wraparound expansion, effective November 30, 2022	

The Oregon Health Authority (OHA) is expanding Fidelity Wraparound eligibility to fee-for-service (FFS) Oregon Health Plan (OHP/Medicaid) members. This expansion allows:

- Outpatient behavioral health programs to become approved Fidelity Wraparound providers, and
- Existing Wraparound programs to offer Fidelity Wraparound to FFS OHP members.

OHA will approve and disburse flexible funding requests to Wraparound programs. You can find the form <u>here</u>. On February 1st 2023, OHA will update the <u>Behavioral Health FFS Fee Schedule</u> to add procedure code H2021 (Fidelity Wraparound Care Coordination) with a rate of \$27.32 per 15 minutes, effective November 30, 2022.

Why is this happening?

The intent of the expansion is to increase provider capacity so that eligible youth who are FFS OHP members can access Fidelity Wraparound.

What should you do?

To become an approved Fidelity Wraparound program: Please contact OHA to learn about the process and existing Wraparound rule set 309-019-0162 through 0163. OHA and the Portland State University System of Care Institute will identify and support the training and certification needs of new programs. Please contact <u>orwrap@pdx.edu</u> if you are interested in becoming an approved Fidelity Wraparound provider.

To bill OHA for Fidelity Wraparound Care Coordination services provided on or after November

30, 2022: Fidelity Wraparound Programs may now use code H2021 in conjunction with codes T1016 and H0038 depending on the services rendered. Bill through the MMIS Provider Portal at https://www.or-medicaid.gov. To learn more about billing OHA, please visit the OHP website.

- For services provided via telehealth, follow Medicaid telehealth policy and add the GT modifier.
