General Notes

Under Section E. Adherence to Measure Specifications, if you looked for a population to include
in the denominator but did not have any consumers who were part of that population, you
should still select "Yes". For example, if you looked to include Veterans in the total population
for the denominator but found that the population of Veterans was 0 for the demonstration
year, you would still select "Yes".

Case Load Characteristics

- Report age of consumer at the time of the first visit of measurement year
- Report insurance status at the time of the first visit of the measurement year

I-EVAL

- Report age of consumer at the end of the measurement year
- Data Source: Medical Records
- Reminder: This metric has a 6 month "look ahead" period for the denominator (see technical specifications)
- For Metric #1, include consumers who contacted the clinic for an initial evaluation but never received an initial evaluation.
- For Metric #2, exclude consumers who never received an initial evaluation.

BMI-SF

- Additional Codes Allowed: H0004, H0039
- Report age of consumer at the date of service
- Data Source: Medical Records
- Reminder: This measurement period for the numerator is the measurement year and the previous 6 months (see technical specifications)

WCC-BH

- Additional Codes Allowed: H0004, 90832, 90834, 90837, H0039, 90791, 90792
- Report age of consumer at the end of the measurement year
- Data Source: Administrative or Hybrid
- Providers may calculate this measure using sampling, see technical specifications for details
- Reminder: for the Hypertension diagnosis you must confirm the diagnosis anytime during the
 enrollee's history on or before the first six months of the measurement year (see technical
 specifications)

TSC

- Reminder: Numerator measurement period is the measurement year and the prior year (see technical specifications)

- Data Source: Medical Records
- Reminder: Measurement period for numerator runs from an individual's index date to the point 12 months ± 30 days afterwards (see technical specifications).
