


Income limits for OHP health-related social needs benefits

Follow the steps below to see what incomes qualify for Oregon Health Plan (OHP) health-related social needs (HRSN) benefits. To qualify, a member's yearly income must be 30% or less than the area median income (AMI) where they live. NOTE: Each HRSN benefit has different requirements to qualify. Step 1: Go to the Department of Housing and Urban Development (HUD) [Income Limits Documentation System webpage](#).

Step 5: In the table, find where it says “Extremely Low Income Limits”

Step 6: Find the column under “Persons in Family” that matches the member’s situation.

Step 7: See if the member’s yearly household income is at or lower than the income listed in the table. If it’s at or lower than the limit, then it meets the income requirement for some HRSN benefits.

Step 8: Stop here. You have the income information you need. You don’t need to click on the blue button that says, “Click for More Detail”.
