

#### **QUICK FAQS:**



- APPLICABILITY: ASAM OARs apply to all SUD providers, regardless of population served, including age and payer type.
- > <u>STREAMLINED</u>: programs will submit one application for all levels of care per OP, RES or WM program. The existing certificate or license will be updated to include all approved ASAM Levels of Care.
- LEVEL OF CARE APPLICATIONS: will be emailed to providers by June 1, 2023 and are due October 1, 2023. Technical assistance will be provided through these meetings and by Compliance Specialists.
- COMPLIANCE: tools will be developed that all HSD Compliance Specialists use for program renewal reviews. These will be shared with providers.
- > ASAM REVIEWS: begin April 1, 2024
